- 2. Delegate authority to the relevant Cabinet Member and Executive Director, to make decisions regarding:
 - publication of statutory notice and consultations on the proposed expansions as part of the supply strategy - table 1 of the report.
 - the development of provision for children with special educational needs and consultation on expansion proposals paragraphs 3.26-28 and table 3 of the report.
- 3. Note that the Cabinet Member, under the Leader's delegated authority, has determined that the proposed expansion of St Joseph's Catholic schools should not go ahead.
- 4. Agree to the publication of statutory notice with a 4 week representation period on the proposal by Parish Church schools to change its category and name from Voluntary Controlled to Voluntary Aided and its name from 'Parish Church' to 'The Minster' paragraphs 2.5 & 3.23-25 of the report.
- 5. Note that consultation on the 2016/17 Admission Arrangements for Community, and Voluntary controlled schools started on 08 December 2014 and will end on 02 February 2015 and that the report will be presented to Cabinet in February to agree the 2016/17 Admissions Arrangements.
- 6. To agree the proposed Schools' Annual Maintenance Plan for 2015/16 Appendix 2 of the report.

- (a) This relates to new changes that have not yet been designed or implemented. The saving is targeted for 2016/17 to allow time to get the changes in place. It relates to Minor and householder applications. Consideration of these by committee, costs considerably more than if they are determined under delegated powers. We shall look at implementing changes to the committee arrangements where these applications are determined under delegated powers rather than at committee. Ward members will still be consulted on them and can comment. Officers will take their views into account in arriving at a recommendation as they do now.
- (b) before the 2016/17 budget is set, Cabinet Members, in consultation with the Scrutiny and Strategic Overview Committee,

will review whether this (resolution 1(a) above) is the best way forward for planning referrals and whether an alternative can be found.

2. that the remaining recommendations arising from the meetings of the Scrutiny and Strategic Overview Committee on 9 September 2014 and 17 December 2014 be received and will be responded to in the final budget report proposals to be submitted at the Cabinet meeting in February..
