1. **RECOMMENDATIONS**

1.1 The Corporate Parenting Panel is asked to approve this revision of Croydon's Corporate Parenting Pledge to Looked after Children

2. EXECUTIVE SUMMARY

Earlier this year the Corporate Parenting Panel requested that the Children in Care Council undertake a revision of the Corporate Parenting Pledge which was last updated in January 2012. This revision has been the focus of considerable work and discussion by the Children in Care Council and on their behalf I am presenting it in this report for the Panel's approval. The Children in Care Council are of the view that the Pledge should not include visual images or 'fancy' graphics because "it is much too important for that" and should present as a contract.

The Children in Care Council have also prepared a questionnaire that they suggest the Independent Reviewing Officer should use in every review to ensure that in the view of the child the Council is keeping its corporate parenting pledge to them. This proposal is under discussion with the Safeguarding and LAC Quality Assurance Service.

The revised Pledge was presented to all social workers and managers in the Looked after Service during the conference held on 10 May 2013 and social workers and their managers were asked to give their personal commitment and promise to ensuring that the Pledge is delivered to the children they are working with. An awards and recognition event for looked after children is being planned jointly by the LAC Service and the Virtual School for October 2013, and it is intended to present the Pledge to elected members, foster carers, parents and friends and family of looked after children at that event.

The Pledge will be sent to all looked after children and to their foster carers with an accompanying letter from the Children in Care Council explaining what the Pledge means as the contract between Croydon as the Corporate Parent and the child in its care, and how the child can hold the Corporate Parent accountable for delivering its promises to them, through the carer, social worker, review meeting, IRO, and the complaint process.

The Corporate Parenting Panel additionally requested a response from Children's Social Care Management to the suggestions made by the Children in Care Council to Panel at the meeting of the Panel on 20 March 2013. Unfortunately discussion with the Children in Care Council about these suggestions has not been progressed because recent meetings of the CiCC were cancelled because of exams, but Martin Hudson and Dionne Sang will be progressing at their meeting with the CiCC on 18 June and will report back on to Panel.

3. Revision by the Children in Care Council of the Corporate Parenting Pledge
