# 4. RESPONSES TO PETITIONS

4.1 Petitions presented to the Council meeting on 28 January 2013, and the relevant Cabinet Member response, as follows:

4.2 Petition presented by **Councillor Susan Winborn** on behalf of residents "As parents and carers of Park Hill Infant School children we request that the Council urgently act to ensure that permanent building works take place next summer (school holidays) 2013. For this to be possible we ask that the council ensures that a relevant planning application is lodged in January 2013,

Our recent expansion at the council's request from 2 form to 3 form entry has stretched our facilities to unacceptable levels which now endanger pupil health and safety. The old hutted classrooms in our school are no longer habitable for pupils and there has been recent flooding and damaged to these hutted classrooms. The newer temporary classrooms are also due to be replaced with permanent buildings.

We the undersigned want the Council to urgently follow through on its commitment with regard to permanent build without any more delay."

# 4.3 Response from Councillor Tim Pollard, Cabinet Member for Children, Families and Learning.

We share the view that the temporary classrooms should be replaced this summer and have been working with the school to achieve this. I understand that the concerned parents and carers who raised this petition are now aware of the progress that is being made.

In fact a Planning pre-application was lodged in November 2012 and active discussions with Planning officers resumed following a meeting at the school on 16 January at which the details of the works to be carried out were agreed. The pre-application process will ensure that when the formal planning application is submitted it should be approved. At present we remain on schedule to carry out the works in the summer break.
