Latest News

Happy New Year everyone. The last seven months of 2014 were hugely positive for Croydon and I am certain that 2015 will deliver even more improvements for our residents, businesses and visitors.

At Budget Scrutiny in December we outlined our plans for tackling the £100m 'black hole' left by the outgoing Conservative administration and how we will tackle the 45% cut to funding for essential services imposed on Croydon by this Conservative-led coalition government.

The good news is that we will be delivering a Council tax freeze. We have been able to do this by writing a three year budget programme that refocuses our limited resources on front line services. We will be undertaking truly innovative efficiency programmes to reduce our back office costs and looking to work with people that need our help much earlier to reduce dependency on more expensive, acute services.

As you will all know, we have also been working hard with the government to deliver a fairer share for Croydon. We recognise that there isn't more money to be thrown at our problems but we do believe that the overall pot of funding can be distributed in a fairer way. Our negotiations with the government have led to their agreement to work with us on delivering a 'growth zone' in the borough. This will devolve significant powers to us, allowing us to refocus further available funding in the area on the services that matter most locally.

Delivering our Ambitions

At the December Cabinet, we considered a new Domestic Abuse and Sexual Violence Strategy. We are determined to do everything that we can to both tackle and prevent these awful crimes and to make Croydon a White Ribbon Borough. We have launched a petition to the Government seeking the creation of a national register of domestic abuse offenders. This would be a significant tool in tackling domestic violence and I would be grateful if everyone would consider supporting this petition – it can be found

We also considered new plans to redevelop the Taberner House site. I am delighted to say that the new plans will dramatically reduce the encroachment on the Queen's Gardens and prioritise

improvement work to this treasured public space. The plans will also deliver a greater number of affordable homes – one of our key priorities to help tackle the housing crisis in the area.

The 'Best Start' report agreed at the Cabinet meeting outlines our plans for delivering better services for our youngest residents. We will be bringing together a range of services, including health visiting, early learning and childcare, family support and children's centres into one integrated service. I am delighted that families from across the Borough have been put at the heart of the design of these services.

The 'Employability, Jobs & Skills - Local Jobs for Local People' report forms part of our overall plan to deliver 16,000 new jobs in the Borough. In partnership with Job Centre Plus, we will deliver a new job brokerage service that will be a one stop shop where Croydon residents can receive advice about their employment options and training needs, and where employers can recruit quality staff.

The Cabinet also considered two reports focused on our transformation strategy. This strategy will help us to deliver the significant savings required while maintaining vital frontline services. The first report, 'Digital and Enabling' will develop and apply digital solutions that help reduce costs and streamline the way in which the Council does business. The second report, 'Contract Management Transformation', will deliver a more outcome and commercially focused approach to how the Council procures goods and services. This new strategy will save £2m in the next financial year alone.

The Cabinet also agree that we work with our geographical neighbours to form a 'South London Partnership Joint Committee'. This important step will help to give South London Councils a unified voice, irrespective of political persuasion, that will help us to collective engage more successfully with Government departments in delivering a better deal for South London overall.

Finally, we considered the current in year financial performance. While we continue to tackle the projected overspend inherited from the previous administration, we are now in a much better position than the Council has been at this stage in the past two years and we have taken into account where overspends are occurring when preparing the budget for next year.

January's Cabinet meeting will provide an update on how we are continuing to clean up the Borough. The headline news is that 85% of fly tips are now being cleared within 48 hours, compared to the 3% being cleared in that time before we took office in May.

One other area on the January Cabinet that I would like to highlight is the report on financial inclusion. We all know that wages have not kept up with the dramatic rises in the cost living over recent years and too many people have experienced significant problems with debt. This paper will outline our new strategy for supporting people that are suffering such financial problems and also to provide new services that will help prevent many people falling into the cycle of unsustainable debt in the first place.

Delivering our Ambitions

Thornton Heath is to benefit from nearly £3m of investment which will transform one of the borough's major district centres.

Croydon's Growth Plan, approved by cabinet in September, pledges to revitalise the borough's district centres, with Thornton Heath a priority area.

The proposed project focuses on 1km of high street stretching from Thornton Heath Library to the Whitehorse Lane roundabout, encompassing the train station and leisure centre to support trading environment for businesses.



The council will be consulting with the community and businesses about the proposals to transform the area.

Work is scheduled to be completed by 2017/18.

Working Together

Job Brokerage Service

The council is working to ensure that jobs created from major commercial developments in and around the borough go to Croydon residents. The proposal is to launch a job brokerage service where the council will work alongside Jobcentre Plus, local colleges and training providers, to provide employers with three job-ready applicants for every vacancy.

The service will work with employers to come up with a clear pipeline of job opportunities which need to be filled.

There are three major opportunities that will generate jobs in Croydon – the Whitgift redevelopment, expansion of Gatwick Airport and work opportunities from growth sectors such as in construction, retail and information technology.

Local Government Funding

The 2015/16 local government settlement has reinforced the unfairness of the system and the adverse impact for residents of our borough. Croydon has been working with a number of other London Boroughs for a co-ordinated approach to submissions to DCLG on this year's settlement.

This is in addition to our ongoing work with Ministers and Shadow Ministers regarding the various areas where Croydon residents are penalised. As detailed previously, this includes the disconnect between the Local Housing Allowance and rent levels, the underfunding of health services in the borough and the failures generally to recognise the demographic changes in the borough.

Budget

Draft proposals were presented to the Scrutiny & Overview Committee in December.

The Leader and myself made clear the huge challenge, some £100 million savings imposed by Central Government over the next three years, when £100 million has already been found over the last four years.

There is ongoing work on budget options and, in particular, working on how we deliver the various major change projects, known collectively as the 'Croydon Challenge'.

Clearly, there are some tough choices being proposed as part of the Budget process and I want to thank Cabinet Members and officers for all their efforts on this.

Asset Strategy

We are actively reviewing the Council's assets as part of unlocking their potential, both in terms of supporting communities and safeguarding front-line services.

This is being done in a holistic manner. We need to use the assets to help meet the needs of residents in terms of services, meet the financial challenges of the Council, along with helping deliver wider objectives for the people of Croydon, such as regeneration, housing and employment opportunities.

Over the next few months, we expect to be able to present specific proposals.

Facilities Management

We are about to publish the procurement strategy for Facilities Management. Very detailed work has gone into making sure we have the right strategy. Our proposed strategy will see the Council move away from an all-encompassing quite rigid single contract, to a number of flexible lots, at least one of which is anticipated to be brought in-house.

Procurement and Commissioning

I was pleased to speak at the Strategy Commissioning Procurement and Performance team's annual conference in December. There was real energy at this conference, showing that staff are continuing to embrace the challenge of a new approach to commissioning, procurement and contract management.

On January 22, we will be holding the Value Croydon event, which is a way of linking major suppliers and Council departments with local businesses. This will show how we are actively promoting local businesses.

Valuing our Staff

With a tough financial context, it is even more important that our staff are treated with dignity and respect and are valued.

This is why we have given new impetus to our staff networks. This has included relaunching some and setting up new ones, such as one for staff with disabilities.

In addition, and contrary to the approach suggested by the Opposition, we value the relationship with the trade unions and consider that they should be given proper facility time and resources to support staff and ensure the staff's voice is heard.

IT

It is essential that we have the right IT infrastructure. In particular, we need this in order to meet the needs of residents, such as with the MyCroydon app and online interactions with the Council and so that we deliver the Digital and Enabling project.

Whilst there is still a lot of work to do, starting from a low base, there are now encouraging signs with the progress on our IT infrastructure and making sure we obtain the right level of service from our main IT supplier.

In June 2014 we made a commitment to make Croydon the cleanest and greenest borough in London through a programme of education, enforcement and making it easy for residents to report issues.

Don't Mess with Croydon, Take Pride is a four year campaign that will require continuous education, enforcement and review of the services we provide.

In the few short months so far the improvements in every area has been outstanding and a testament to how the Council's staff and those of our contractors have bought in to the campaign. As a Council we now measure performance more efficiently and have improved our accountability with the performance dash board we publish.

88% of fly tips cleared within 48 hours compared to only 3% 2013/14. An average of 46 fixed penalties for fly tipping issued per month compared to only 20 in 2013/14. Over 20 Interviews under Caution leading to cases booked in court, an average of 5 per month compared to only 1 in 2013/14. 6 warrants granted requesting seizure of vehicles involved in fly tipping. Arrangements in place to display crushed vehicles and name & shame those prosecuted. National BBC coverage of our campaign and other Borough's interested in adopting our approach.

Most importantly public is feedback saying that whilst there is still a long way to go, they recognise things are improving and that they support Don't Mess with Croydon, Take Pride campaign.

New initiatives being proposed:

In 2015 we will be carrying out an education drive involving residents, schools, landlords and businesses this will include talking to residents with eyesore gardens, signing up traders to an agreement with us to dispose of waste correctly which will be available for display. Promotion of recycling in our schools, community group meetings and working with our clean & green Street Champions we will also sign up residents to display a charter/agreement.

Having identified the problem of black bags from flats above shops along our district centres we are piloting a new bin that's part recycling, part landfill that's cleared daily with the street bins. If the Crystal Palace Triangle pilot works we can roll out to other problem areas.

Homes for the Future



During December, in my role as Cabinet Member for People and Communities, I visited the four Council Day Services across the borough. These are the Reablement Resource Centres at Addington Heights, New Addington; and Coleby at Fellowes Court in Addiscombe and the Dementia Day Services, at Langley Oaks in Selsdon and the Marsh and Willow Units at Heavers Resource Centre in Selhurst.

During the visits, I took the opportunity to have first-hand contact and engagement with clients, carers and staff. I

spent time with clients in a variety of settings including participating in group activities, joining clients for lunch and attending two festive events where I also met with relatives, carers and centre volunteers.

I was able to see and hear about the positive impact of the professional level of care and services provided at these excellently facilitated and equipped Centres. I was informed by both clients and carers of the significant difference the Centres and the staff teams make in enhancing their quality of life and in enabling clients to maintain health, wellbeing and independence for as long as possible.

Feedback from the visit was that Staff teams were very appreciative of the time I had spent at the centres and welcomed my offer to have continued contact with the centres.

The Care Act 2014

Market Position Statement – this duty is to assist the providers of care in Croydon with a statement to indicate the current position of the market and the likely future requirements to ensure that the necessary services are available to meet the demand, there is now an annual requirement to publish this document. Engagement and consultation with providers, including those in the voluntary and community sectors has begun. Its main purpose is to find out through feedback whether the approach we are taking and the "style and format" of the draft Market Position Statement is one that will be useful to provider colleagues as a helpful and relevant tool that they can use in their own service and business planning, The final version will come to cabinet for approval in March.

Think Autism Capital Grant (£18,500)

Further to the letter from Department of Health dated 7th November, Croydon plan to use the funding to develop and roll out an e-learning module co-produced with parents of children with ASD and young people or adults with ASD. The objective of the learning tool would be to raise awareness of ASD and the needs of people with ASD among front-line practitioners and the wider community as part of the wider strategy for Croydon to be an Autism-friendly borough. The local organisations, businesses and community groups for whom an agreed proportion of the workforce complete the training, could then be awarded a Croydon autism-friendly kitemark. This would be using a similar awareness-raising approach to the successful National Dementia Friends campaign. The £18.5K funding would be used to develop the module (using the existing local e-learning platform which can be used by anyone who lives or works in Croydon) and contribute to the engagement of service users in co-production and the roll out of the module across the Local Strategic Partnership and community.

Croydon General Practice 2014

The Croydon Public Health Intelligence Team recently published annual profiles for Croydon GP practices and GP clinical networks.

The GP Network Comparison Profile shows variations across Croydon's six GP clinical networks in demography, disease prevalence, activity and quality of care. Each practice also receives its own individual profile, comparing data with national targets and other practices in Croydon.

The profiles are used by practices and GP clinical networks within Croydon Clinical Commissioning Group to assess the needs of their population, to inform clinical governance, and to inform decision making.

DELIVERING AMBITIONS

Croydon's Local Alcohol Action Area

In February 2014, Croydon was awarded Local Alcohol Action Area (LAAA) status. Led nationally by the Home Office and Public Health England, the LAAA programme aims to tackle the harmful effects of irresponsible drinking, particularly alcohol-related crime and health harms. Croydon's alcohol partnership, established by the LAAA, is led by the council and includes the police, other licensing authorities, health bodies, the voluntary sector and businesses.

Croydon's LAAA programme has set the following priorities over the coming year:

- 1. To screen more adults for high risk drinking and to offer appropriate support
- 2. To promote safe, sensible alcohol consumption through coordinating and running campaigns
- 3. To prevent violence through sharing information between urgent care centres such as A&E and the Safer Croydon Partnership.

Croydon is also working with the Home Office to explore how new local health powers can influence licensing decisions. Croydon recently hosted a regional event, facilitated by the Home Office and The Portman Group, to explore opportunities for local authorities to work more closely with the alcohol industry.

Annual Learning Disability Joint Health and Social Care Assessment Framework

The annual Joint Health and Social Care Self-Assessment Framework helps local areas check that people with learning disabilities and their families:

- Get the same opportunities as other people such as having a job or being safe where they live.
- Get good access to health services to stop them becoming unwell when this could be prevented.

For 2014/2015 -the process involves health and social care completing a template with a set of questions linked to **3** main areas of focus:

Staying Healthy- This includes getting a good service from the doctors, chemist, dentists, hospital and more.

Being Safe- This is about being safe in lots of different places such as in your home, whilst in hospital or out and about on public transport.

Living Well- This is about making sure people are part of what happens in their area such as taking part in festivals or going to the cinema.

The focus for data collection was for 2013/2014 and there is an additional focus on the views of people with Learning Disabilities and their carer's in relation to two specific questions. To facilitate this a survey was undertaken of carers and also the Learning Disabilities Commissioning team hosted an LD day on November 7th 2014 which was attended by 95 people and included people with a Learning Disability, families, carers, health and social care professionals and service providers.

The two specific questions were:

Staying safe section: B6 Treating people with compassion, dignity and respect What has the support that you have had been like in the last year? Living well section: C8: A question for carers- How satisfied are you that your needs as a carer are being met

How well are we supporting family carers in Croydon?

The result was that attendees felt that both questions could be rated Green on the basis of their experience. The next stage is to complete the rest of the template for sign off by the Learning Disability Executive and the Learning Disability Partnership Board ahead of submission to the Department of Health at the end of January 2015.

Mental Health Older Adults

A multiagency project group led jointly by Dr John Linney, Croydon CCG Governing Body member and Brenda Scanlan, Director, Integrated Commissioning Unit have been progressing proposals to redesign services for Mental Health Older Adults to address project changes in demographics in respect of an increase in ageing population resulting in increased dementia and therefore demand for services.

Three multiagency working groups were set up to progress this work and the recommendations that have been approved by the project board include; Development of Dementia Support workers to work in the community to support navigation of the system, development of one stop shop directory of support services and training opportunities, integrated working across primary, community, secondary and social care via Community Mental Health Teams and development of mental health older Adults Crisis Management and Home Treatment service. The next steps will include further service user and carer engagement to finalise these proposals and initiate the implementation process.

Bethlem Visit

In December I visited Croydon inpatient mental health services, run by the South London & Maudsley NHS Foundation Trust, based on the site of the Bethlem Royal Hospital. The visit was coordinated by Paul Richards, Croydon's Head of Social Care in the Integrated Adult Mental Health Service and was hosted on the Croydon Triage Ward. There was a round table discussion regarding some of the pressures and challenges in today's mental health services, including issues around staff recruitment, bed pressures and the wider impact of the economic recession. Contributions to the discussion came from Hammond Macaulay, Clinical Services Lead for the Community; Bal Johal, Clinical Services Lead for Inpatients; and the ward multidisciplinary team including the ward manager, ward doctor and ward social worker.

The Croydon Triage Ward provides assessment and care for up to 16 men and women, in separate wings, who have an acute psychiatric illness requiring 24 hour hospital care. The role of the ward is to receive and assess all inpatient admissions for the London Borough of Croydon with an average admission rate of 2-4 people per day. The average length of stay is 4-5 days with a maximum of 7 days. Patients are admitted for an intense period of assessment and / or treatment with the aim of returning them to their communities, sometimes with the support of the Home Treatment Team. Where a swift turnaround and early discharge is not possible then patients may get referred on to one of the acute inpatient units for further treatment.

Following the presentations and round table discussion I took the opportunity of touring the ward with the ward manager and meet several patients on the ward. During my conversations with the patients they commented positively on the quality of the care and treatment they were receiving.

Feedback from both staff and patients since my visit has been that they appreciated that I had taken the time to visit the ward.

Croydon – Food Flagship Borough



Croydon has made significant progress since being granted food flagship status in the Summer. Pivotal to the success of the programme is the innovative Community Food Learning Centre in New Addington.

In addition to the work being undertaken to improve school food and increase uptake of school meals there will be a number of initiatives linked to Croydon's regeneration programme of which the Community Food Learning Centre is an example. On a recent visit to the centre I was impressed at the enthusiasm of the staff and the quality of the facility. Evelyn Findlater, the Chief Executive of Good Food Matters, took me for a tour of the extensive growing area and also the recently built teaching

kitchen where a group of young women were receiving a cooking class.

The project will offer a range of interventions to residents, teachers and pupils in New Addington who want to learn to cook and grow as part of an integrated programme. This will also include engaging with young people not in employment, education or training to link them with careers in horticulture and catering.

Food flagship status also provides local community networks the opportunity to have their innovative ideas around growing and cooking to be funded through a small grants scheme and a Food Partnership Board will oversee the development of food initiatives over the lifetime of the programme.

GROWTH ZONE

The Government, in its Autumn Statement, responded positively to the Council's proposal for a Growth Zone in central Croydon which seeks the devolution of powers to retain Stamp Duty, Business Rates and New Homes Bonus to fund infrastructure development. More detailed negotiations with the Treasury are due to start in January 2015. If agreed, this would go towards funding the infrastructure required to enable further growth in the town centre.

Delivering our Ambitions

DEVELOPMENT COMPANY

The Council is keen to ensure that as much value as possible is retained from the development process to benefit residents. For this reason, a new council Development Company is being established to enable the council to take on the delivery of a variety of sites itself.

Following September Cabinet's in principle approval to this approach, detailed operational proposals are now being worked up to be ready for Cabinet's consideration in the Spring. Sites with capacity for thousands of new homes and jobs have been provisionally identified.

SELECTIVE LICENSING SCHEME

The Council's consultation on a selective licensing scheme to improve homes in the private rented sector has been extended following a High Court judgement on Enfield Council's scheme. The new consultation deadline is March 2nd with the results to be presented to Cabinet in March.

SAVING QUEENS GARDENS

In December, Cabinet also agreed revisions to the Taberner House redevelopment scheme including: the Council taking a direct role in the development of Phase 2; an increase in affordable homes from 15% to 30%; an increase in disabled parking; and increasing the size and quality of open space remaining at Queens Gardens. Demolition of Taberner House continues in preparation for start on site of the new scheme.

OTHER MAJOR SCHEMES

Following a very productive pre-inquiry meeting on 9th December, final preparations are underway for the start of the Whitgift CPO Inquiry on 3rd February. A second set of Business Surgeries, with specialist advisers in attendance, is also being provided on the 20th and 27th January in Bernard Weatherill House. The aim is to assist businesses with their transition to new properties.

Two major Council-led regeneration schemes, at College Green in the town centre and Central Parade New Addington, moved a step closer with tenders being issued to secure multi -disciplinary consultants to take the schemes through detailed design and the planning process. Appointments are expected in March. A commitment has been made to start Central Parade on site early in 2016, with the first phase to include a new leisure centre.

The development of 675 new homes at Cane Hill and a new food store at Lion Green Road in Coulsdon remain on hold pending a judicial review in the High Court - the date for this is still to be confirmed.

EMPTY HOMES CAMPAIGN

The Council is launching an Empty Homes Campaign on 13th January across the borough with a poster campaign linked to the launch of the new option on the Council's Report It App for reporting empty homes. The aim is to encourage residents to report empty homes that are not only affecting their neighbourhood but that could provide a much needed home for a homeless family.

COUNCIL LEADS THE WAY ON FIRE SAFETY IN SHELTERED HOUSING BLOCKS

Croydon is one of the first local authorities to support the London Fire Brigade initiative to require sprinklers in our new build properties and we are now applying the benefits of sprinklers to our existing housing stock.

We have committed to installing full retrofit sprinkler systems to all six of our special sheltered blocks thereby ensuring maximum protection is provided to our most vulnerable residents. This will provide protection throughout each flat as well as all communal areas within the building. The first block completed was Truscott House and was subject to an award from the LFB in November. The remaining five blocks are due to be finished in the next couple of months.

We have also taken the initiative (possibly the first authority in London) to install portable sprinkler systems within the homes of very vulnerable individuals in our retirement housing blocks where risk assessments have identified specific individuals would be unable to self-

evacuate were a fire to occur in their own flat. This work was completed during 2014 and means that specific protection is now in place for those who most need it.

All of the sprinkler installations will lead to increased safety for vulnerable residents as they stop fires from spreading and help put them out quickly and help save lives.

This work led to the Council winning £7,500 through the LFB's competition for sprinkler funding and drew the following comment from the LFB Borough Commander: "One of our priorities is to reduce fires in care homes and sheltered accommodation so it's great news that Croydon Council has agreed to install sprinkler systems in its existing special sheltered housing complexes. We're delighted at the example they're setting and we hope that more local authorities and housing providers will follow its example."

PLANNING AWARDS

Over recent years the planning division of the council has been developing a strong reputation to establish itself as a leader in innovation and has become nationally acknowledged for best practice in proactive planning through its work with the development industry and its innovative pre-planning application processes. The division have received considerable recognition for masterplans and spatial strategies produced such as the East Croydon Masterplan and the Local Plan with its innovative place based methodology identifying the 16 places of Croydon.

In 2014 the planning division was successful in receiving two further awards endorsing the good work that is currently being carried out. The award for Planning Authority of the Year at the was awarded at the inaugural MIPIM UK Awards hosted by Estates Gazette and Planning Policy Team of the Year at the Planning Awards. Judges were impressed with how the Councils local plan had divided the borough into 16 distinct places, identified through consultation with communities and by analysis of areas' characters and functions, how these could change over the next 20 years and how the council aims to improve poorer-quality areas over the plan's lifetime.

RESIDENT INVOLVEMENT AWARDS 2014

The hard work and achievements of council tenants and leaseholders was celebrated at the resident involvement awards ceremony Wednesday, 17 December 2014.

The annual event, organised by the council's resident involvement team, recognises the effort people put into making their communities better places to live, whether that involves improving services or housing estates.

A special buffet was laid on for residents at the Clocktower Café in Katharine Street, Croydon, as a "thank you" from the council to those who have regularly taken part in activities organised by the resident involvement team.

The awards were presented by the Deputy Mayor of Croydon, Councillor Patricia Hay-Justice and Councillor Alison Butler, deputy leader of the council and cabinet member for homes and regeneration

Residents were nominated for awards in four categories by fellow residents, councillors and officers.

Latest News

Flooding Update

The flood alleviation measures in Purley and Kenley are progressing well and most of the proposed works have now been completed. The Council is working jointly with Surrey County Council, Tandridge District Council, Environment Agency, Thames Water and Sutton & East Surrey Water to identify potentially affordable and viable solutions that could help to minimise the impact of flooding in the longer term and protect key assets and the most vulnerable. We have commissioned Atkins, who are one of the world's leading design, engineering and project management consultancies, to undertake the study and they commenced work in October 2014, they are currently in the information gathering phase.

Repair & Renew Grant Scheme – to date the Council has received 36 applications from residents and businesses for funding to implement flood resilience measures to protect their properties and has recently approved the first set of works to proceed on 3 businesses and 1 residential property. These works would be carried out and completed by the end of January 2015. As the grant is only for measures over and above that claimed from the insurers, more residents and businesses are being urged to obtain their insurers report and apply.

Cycling Update

We are working with TfL and Sustrans to deliver the Croydon to Waterloo cycle 'Quietway'. TfL recently wrote to us offering funding and other resources to deliver a further three Quietways to connect central Croydon with Greenwich, Crystal Palace and Worcester Park (Sutton). We welcomed the offer, making some suggested improvements to the proposed routes.

We are due to start in February widening and improving the existing off road cycle path shared with pedestrians at the top of Gravel Hill. Work is almost complete on a new 1.3km off road section of cycleway along Lodge Lane, from Kent Gate Way to King Henrys Drive. This will provide an almost continuous traffic free link from King Henrys Drive to Featherbed Lane in the west and to the borough boundary with Bromley in the east.

Delivering our Ambitions

20 mph Areas

The Council has set up a working group to further develop the proposed area wide 20mph speed limits across the borough. This working group, which held its second meeting on Wednesday 17th December, has discussed a number of issues including, the proposed size of the areas to be treated each year, the exempt roads within these areas, the monitoring of the existing traffic speeds, and how local people's views will be surveyed. Further working

groups are due to take place over the next few months, with a detailed report on the proposal to be presented to Cabinet in March for approval.

Play Streets Update

The Council is currently supporting residents in 9 roads who have expressed an interest in having a Play Street. Play Streets are resident led initiatives and so it is for them, following consultation with their neighbours, to decide whether to go ahead with the application for a Play Street and when to hold it.

The Council have prepared a guide for residents which explains what they need to do to arrange a Play Street as well as useful documents that they can adapt for use in their own road. This is on the Council website at:

The indication from residents is that they are proposing to start their Play Streets from Spring 2015. Where the Council agrees a road closures it will initially be for three sessions. This will allow organisers and those residents that have reservations the opportunity to try out a Play Street and identify problems before a longer term arrangement is put in place.

Working Together

Annual TFL Bus Meeting

We held a new style engagement meeting with TfL (the very first in London) to discuss longer term and more strategic bus network matters. We focused on the expected growth in Croydon and how the bus network might expand to support it, agreeing to meet early in the New Year to begin working in more detail. We took the opportunity to highlight the need for more direct bus connections to Croydon University Hospital.

New Addington Bus Review

TfL has undertaken a detailed review of bus services in the New Addington area and has just consulted on proposed improvements. TfL distributed leaflets explaining the proposals to rationalise the services. It also hosted 3 drop-in sessions to discuss the proposals with residents which Councillors also attended. We have welcomed the proposals but suggested how they might be improved further. Discussions between TfL and Croydon Council will continue prior to a TfL announcement expected in spring 2015.

Responses to the Old Oak Common and Bakerloo Line extension consultations

TfL recently consulted a proposed station at Old Oak Common (which would provide interchange between HS2/Cross Rail and the West London Line) and a proposed extension of the Bakerloo Line. We welcomed the Old Oak Common Station proposal as it would provide an alternative route from Croydon to access HS2, removing the need to go through

central London to Euston. It would also provide other improved links including to Heathrow. We gave our support to 'Option A' which provides the potential for train services from Croydon using the West London Line to directly connect into the proposed station.

We similarly welcomed the Bakerloo Line proposals. The proposed interchange at New Cross Gate between the Bakerloo Line and mainline line and London Overground services would give improved connectivity and journey choices to the people of Croydon. The proposed Bakerloo Line station at Elmers End and interchange with Tramlink, would provide further connectivity benefits. Noting the consultation was also intended to gauge support for a possible extension to Bromley Town Centre, we made the point that the obvious alternative is the Croydon town centre.

Our response to Network Rail's Sussex Route consultation

Network Rail has recently consulted on its 'Sussex Route Study'. The study proposes improvements at East Croydon Station in the form of two additional platforms and extending the passenger concourse. We welcome the proposals but suggest they should be more ambitious and look to deliver 21st century rail stations at both East and West Croydon. The proposals also include straightening the tracks through East Croydon and grade separating the lines to Victoria and London Bridge Windmill Bridge Junction (north of East Croydon). Both proposals are welcomed for the improved journey speed, capacity and reliability that would be achieved for services between East Croydon and London Bridge and Victoria. Our response to the consultation makes clear that if Norwood Junction Station has not already been made accessible, then works to make the station accessible should be part of the implementation of the study.

Giving children the best start in life in Croydon

We know that the early years are the most influential time in the development of a child, when their brain grows the fastest and when love and security are crucial. The council and its partners believe that it is vital that all young children get the best start



in life and propose to bring together key services including health visiting, children's centres, early years and voluntary sector into a single service model.

Thanks to just under £1.5m from the Department for Communities and Local Government (DCLG), we are able to start planning the details of an integrated service for under-fives and their families, called Croydon Best Start.

The Best Start service, which is being developed with the help of local parents, will provide:

- a comprehensive map of local support groups and services for parents
- more investment in community resources so that parents can help themselves and each other
- a more joined up approach so that families can access the services they need when they need them, and as early as possible
- a collaboration to drive up teaching standards in pre-school nurseries and childcare
- more support to ensure strong attachment and bonding of babies and young children with their parents
- a network of advisers to work with families at risk of domestic violence
- relationship advice and support for parents
- more opportunities for parents to access training and employment

The proposals were approved at a meeting of Croydon's cabinet on 15th December, and the council and partners will now be working up the detailed proposals.

South London SEN Commissioning Programme

The South London SEN Commissioning Programme was launched by Croydon in September 2013 to collaborate with neighbouring boroughs on the commissioning of good quality special educational needs placements in the nonmaintained/independent sector.

The Programme now covers most of South London and constitutes a partnership between 10 South London Boroughs. With a collective spend of nearly £70 million across 200 independent and non-maintained schools and colleges, it is the largest SEN focused sub-regional group in the country. Already the programme has achieved tangible benefits for the participating boroughs. These include savings of circa £700k and improved systems in place to ensure that commissioners in each of the boroughs are making informed and intelligent commissioning decisions.

In November 2014, the programme was successful in securing Transformation Challenge Award funding of £710k from the Department for Communities and Local Government. This funding will enable the programme to make the partnership stronger and explore integrated commissioning options across the 10 boroughs. It is anticipated that with integrated commissioning, the boroughs will be able to achieve substantial savings as well as the best outcomes for our children and young people with special educational needs.

More schools improve from requiring improvement to good

In the summer of 2012 64% of Croydon's schools were judged by OfSTED to be good or outstanding. Focused and intensive work by the school improvement team, involving both challenge and support for school leadership teams and class teachers, has resulted in this percentage now standing at 82% in the autumn term of 2014. Particularly notable in this improvement is that of the schools previously judged to be requiring improvements 100% have converted to a judgement of good at their next inspection, which is a significantly higher rate than seen nationally.

Ambition Festival

The centre of Croydon will burst into life next July as a major new festival, Ambition, takes over the town for four days of music, comedy, theatre, spoken word, dance and art. The festival, running from 23 to 26 July, will be funded by the council but is to be largely curated and programmed by a diverse range of promoters and arts groups. The festival is welcoming approaches from other music and arts organisations with ideas about how they could take over a stage or venue for a day – or even the whole weekend.

I have been campaigning for several years to see a major festival return to our borough after the success of the Croydon Summer Festival "World Party" and "Mela" which was regrettably cancelled by the last Political Administration of the Council as part of their policy to degrade the Cultural offering in our borough. Know your Funeral Rights (rites) took place on 17th October a Croydon Crematorium. This seminar is designed to dispel some of the myths surrounding burial, cremation and arranging a funeral culminating in a tour of the crematory.

Christmas Memorial Service – One of our most popular annual events attracted well over 100 attendees. A collection was held on behalf of a local charity Woodside Bereavement Services with £150.00 being raised.

New Burial Land

The appeal in relation to our unsuccessful planning application to extend Greenlawns Memorial Park took place on 13th January 2015 at Tandridge District Council Offices. A considerable amount of preparatory work has been undertaken to ensure we are best placed to promote our case to the investigator. We hope to have a decision regarding the appeal by mid February.

A specification in relation to groundworks has been put out to tender enabling works to commence in the summer months should the above appeal be successful.

General

Head of Service, Kevin Pilkington achieved the Institute of Cemetery and Crematorium Managers Diploma in October 2014 following several years of study. This is the only nationally recognised, accredited qualification for cemetery and crematorium managers. Studies will continue as and when any additional modules are added and for continual professional development.

Web pages have been reviewed and amended in line with corporate requirements and are now far clearer and more user friendly.

Two areas of paving have been refurbished and replaced in the Crematoriums Garden of Remembrance resulting in a considerable improvement. These areas will now be considered for the introduction of new memorial schemes for cremated remains.



Dialogue has begun with a local NHS Trust to assist with post mortems whilst the public mortuary undergoes a major refurbishment. Should everything be agreed in time it is hoped that works will commence in the Spring of 2015 and be completed by the Autumn

Latest News

I am pleased to report that the police, supported by the Council and other partners carried out a large gang and drugs crackdown in West Croydon & Broad Green. This was started by Police in Croydon carrying out a series of dawn raids on 10 December as part of an operation led by the Met's Trident Gang Crime Command to tackle gang crime, drug dealing and anti-social behaviour in and around the West Croydon area. A total of fifteen warrants in coordinated raids across Croydon, Lambeth, Sutton, Lewisham and Bromley resulted in a total of 14 arrests for a range of drug offences, including Conspiracy to Supply drugs. Those targeted today are all believed to be either gang members, involved in gangs or involved in the supply of drugs in and around the West Croydon and London Road area of Croydon. The raids come on the back of several months of ongoing work by police, in partnership with Croydon Council to tackle drug dealing, gang crime and antisocial behaviour in the West Croydon, London Road and Broad Green areas. These raids were followed up by a concentrated presence of police and council officers in London Road providing reassurance and engaging with local residents and shop keepers.

Running alongside this has been the Met Police firearm surrender initiative which has 116 weapons recovered and over a thousand rounds of ammunition handed in at police stations across South London, including 12 weapons handed in at Croydon police station.

Croydon police have launched a joint-initiative with Croydon Council, calling for help from local businesses to help identify potential victims of child sexual exploitation. More of which can be found on this link.

On a more local level, a BMW a property-owning benefit cheat who drove around in a new top of the range BMW and sent her children to private school has been jailed after being convicted of fraud.

And Angella Brown, of Silverleigh Road, Thornton Heath, was found guilty of nine offences taking place from 1999 to 2009, where she pocketed £43,000 in benefits and income support she wasn't entitled to.

A scrap metal dealer from Croydon has been jailed after he accepted stolen crematorium plaques and other stolen items at his scrap yard. This was a particularly nasty offence causing much distress to those who had lost someone.

Dealing with anti-social behaviour that can so blight our lives is important. On 2 December 2014, Justin Sewell, who had been playing his music so loud as to cause nuisance to his neighbours, was fined £420 plus costs at Croydon Magistrate's Courts. The court also made a forfeiture order to dispose of his seized equipment. His neighbours, one of whom is an NHS nurse, can now enjoy some peace and quiet in their home. Between 14 April and 7 April 2014, the pollution team received 27 complaints from 6 local residents about noise from his flat, and a statutory abatement notice was served.

Equality Annual Report

The Council has produced its equality annual report for 2014-15. A fundamental tenet of our pledge to be ambitious for Croydon is to achieve the highest standards

of excellence in equalities practice, working closely with our partners in the public, business and voluntary sectors. The annual report sets out some significant steps the Council and has taken over the past year to embed equality throughout the organisation. It also includes some examples of good practice that we have developed to ensure that our services are fair, inclusive and accessible to our residents.

Croydon Congress

Croydon Congress was held in November 2014 and brought together over 120 leaders and stakeholders from the borough including businesses and voluntary and statutory organisations. Congress focused on the issues of opportunity and fairness in the borough. The keynote speaker was Matthew Taylor, Chief Executive of the Royal Society of the Arts. Interactive sessions helped to draw out attendees' perceptions of opportunity and fairness in Croydon and will help inform the activities of the Croydon Opportunity and Fairness Commission.

Multifaith events

Multifaith events, in partnership with Faiths Together in Croydon, were held to celebrate Diwali in November and Christmas in December. Around 100 attendees attended each event. These were both part of a series of community events to celebrate key dates in the faith calendar. At the Diwali event we heard from representatives from the Hindu Council and the Sikh community and had a contribution from local children. At the Christmas event we heard from the Bishop of Croydon about the symbolism behind the nativity story and had contributions from a local primary school and a local flautist. Representatives from the Council, including the Deputy Mayor, also attended a special Hanukkah service at Croydon Synagogue in December.

Active Communities Fund - Micro Grants

The first round of the Active Communities Fund will be closing as this bulletin is published. I look forward to publishing in my next bulletin details of the first successful projects awarded small grants (up to \pounds 5,000) and micro grants (up to \pounds 1,000) from the fund.

The Micro Grants programme is now an open fund with no specific deadlines. I will be meeting with officers every two months to review the micro grants applications which I hope will grow in number as the programme gets more well known and reaches groups which might not have thought themselves big enough to apply for support from the Council.

The programme offers one off grants of up to £1,000 targeting small, Croydon based groups which simply feel they have a good idea for activities address one or more of the programme's priority areas. These are;



- Developing active communities by creating innovative ways of promoting a sense of belonging and cultural activities;
- Giving young people the opportunity to reach their full potential and the confidence to express themselves;
- Helping people care for one another's health and wellbeing, particularly in the priority areas set out in the Health and Wellbeing Strategy 2013-18;
- Developing innovative ways to tackle food and fuel poverty, and support greater access to good quality welfare benefits and other advice:
- Developing a community response to combating domestic abuse and sexual violence.
