### 1. **RECOMMENDATIONS**

- 1.1 That:
  - (i) The Chair, Deputy Chair (majority group) and Vice Chairman (minority group) be appointed (paragraph 4.1)
  - (ii) Three scrutiny Sub-Committees be established (4.2)
  - (ii) The remit of the Sub-Committees as set out in 4.3 be agreed
  - (iii) The members appointed to the three Sub-Committees be endorsed (6)
  - (iv) The Chair and Vice Chair of the three Sub-Committees be appointed(7)
  - (v) Some parameters for the frequency and content of scrutiny meetings be agreed (4.5 to 4.8)
  - (vi) And the dates of Committee meetings be noted (5)

### 2. EXECUTIVE SUMMARY

2.1 The Council's Constitution (Articles 5.01 and 5.02) requires the Scrutiny and Overview Committee (SOC) to appoint its Chair, Deputy Chair and Vice Chair. Article 6.02(k) permits the Scrutiny and Overview Committee to appoint Scrutiny Sub-Committees.

The Committee is asked in this report to appoint the Scrutiny Chairs, establish three Sub-Committees for 2015/16, agree the titles and remits of the three Sub-Committees, appoint the Members of the Sub-Committees, appoint the Sub-Committee Chairs and Vice Chairs and agree some parameters for the number of scrutiny meetings to be held during the year.

## 3. BACKGROUND

- 3.1 Articles 5.01 and 5.02 state that: "The Chair of the Scrutiny and Overview Committee shall be appointed for the Council Year at the first meeting of the Committee, immediately following the Annual Council meeting....The Scrutiny and Overview Committee shall appoint Councillors as Deputy Chair and Vice Chair."
- 3.2 Article 6.2(k) states that the Scrutiny and Overview Committee may: *"appoint such Sub-Committees and task and finish working groups as may be required in order to discharge the Scrutiny and Overview role and shall allocate areas of responsibility to each Sub-Committee and coordinate the work programmes of the Sub-Committees"*
- 3.3 In 2014/15, the Scrutiny and Strategic Overview Committee (SSOC) established three sub-Committees:
  - The Health, Social Care and Housing Scrutiny Sub-Committee which included statutory health scrutiny powers
  - The Children and Young People Scrutiny Sub-Committee which included scrutiny of educational matters
  - The Streets and Environment Scrutiny Sub-Committee included the statutory duty to scrutinise to review and scrutinise the actions of the local Flood Risk Management Authority

The Scrutiny and Strategic Overview Committee retained the statutory duty to scrutinise the work of the Safer Croydon Partnership.

- 3.4 Following the local elections in May 2014 the new administration set out to provide additional resources for scrutiny and in 2014/15 it:
  - Established a third Sub-Committee to scrutinise issues relating to transport, shared road use and streets as well as flooding and sustainability

- Increased the number of scheduled scrutiny meetings from 16 in 2013/14 overall to 25 in 2014/15
- Increased accountability of decision-makers by inviting Cabinet Members to hold question time sessions within the scrutiny framework
- Developed Local Action Mini Reviews as a new way for back bench Members to investigate and report on issues of local concern
- Undertook pre-decision scrutiny on council policies and the council budget and re-visited issues
- Developed a Topic Reports as a means of making review information available in an easily accessible form
- Undertook a number of visits and briefings to help inform Members about topics they would later scrutinise
- Increased engagement by inviting contributions and questions from members of the public, partners and stakeholders, by taking health scrutiny meetings into the community and by web-casting some Scrutiny and Strategic Overview Committee meetings
- 3.5 When considering the arrangements or 2015/16 Members need to give consideration to:
  - An increase in the number of scheduled scrutiny meetings from 25 in 2014/15 to 27 scheduled meetings in 2015/16 including a joint meeting of the Health and Children Sub-Committees and a 'Young People takeover' meeting of the Children and Young People Scrutiny Sub-Committee
  - Allocating sufficient Member and scrutiny officer attention and resources to health scrutiny in what is likely to be another challenging year as it responds to the challenges of the Care Act and current issues within Croydon Health Services NHS Trust.
  - The intention to continue taking Health scrutiny meetings into the community in 2015/16.
  - The remit of the Children and Young People Scrutiny Sub-Committee which includes responsibility for scrutinising safeguarding for children

#### 4. PROPOSALS ON STRUCTURE AND REMITS

Taking into account the above information, it is proposed that the SOC:

4.1 Appoints its Chair, Deputy Chair (from the majority group) and Vice Chairman (from the minority group) for 2015/16.

- 4.2 Establishes **three** Sub-Committees once again in 2015/16:
  - Health, Social Care and Housing Scrutiny Sub-Committee
  - Children and Young People Scrutiny Sub-Committee
  - Streets and Environment Scrutiny Sub-Committee
- 4.3 Approves the following remits for the Sub-Committees:

### HEALTH, SOCIAL CARE AND HOUSING SCRUTINY SUB-COMMITTEE

- (i) To undertake all powers of Health Scrutiny as defined in the Health and Social Care Act 2001 and National Health Service Act 2006 and the Health and Social Care Act 2012.
- (ii) To scrutinise Health and Social Care services.
- (iii) To undertake Housing scrutiny
- (iv) To undertake any relevant functions as prescribed to sub-Committees within Article Six and Section 4E of the Council's Constitution including any referrals from Healthwatch.
- (v) To scrutinise any other matter as prescribed by the Scrutiny and Overview Committee.
- (vi) To nominate two Committee Members to the South West London Standing JHOSC and 1 observer
- (vii) To nominate a Member/s to any other formally convened JHOSC

### CHILDREN AND YOUNG PEOPLE SCRUTINY SUB-COMMITTEE

- (i) To undertake scrutiny of duties and functions of the Council as a local social services authority relating to children
- (ii) To scrutinise all services appertaining to the education and well-being of children and young people including youth services
- (iii) To scrutinise life-long learning
- (iv) To undertake any relevant functions as prescribed to sub-Committees within Article 6 and Section 4E of the Council's Constitution.
- (v) To scrutinise any other matter as prescribed by the Scrutiny and Overview Committee

### STREETS AND ENVIRONMENT SCRUTINY SUB-COMMITTEE

- (i) To scrutinise:
  - The built environment
  - Planning policies
  - Public realm
  - Transport
  - Highways and streets
  - Green and clean
  - The environment, conservation, climate change and sustainability
- To scrutinise Flood Risk Management as required by the Localism Act 2010 and report findings direct to the Cabinet and/ or other partners (see section 1.05(d) Part 4E Constitution);

- (iii) To undertake any relevant functions as prescribed to Sub-Committees within Article Six and Part 4E of the Council's Constitution;
- (iv) To scrutinise any other matter as prescribed by the Scrutiny and Overview Committee.
- 4.4 Note that the remit of the SOC will include the statutory duty to scrutinise the work of the Safer Croydon Partnership as required by the Police and Justice Act 2006.
- 4.5 Agree that the SOC hold no more than **7** meetings during the year (the minimum prescribed in Part 4E 3.01 of the constitution) subject to any additional meetings that the Director of Legal and Democratic Services decides are required in order to consider Call-Ins deemed to be urgent.
- 4.6 Direct the:
  - Health, Social Care and Housing Sub-Committee to hold no more 8
    meetings during the year, including a meeting held in parallel with the
    Children and Young People Scrutiny Sub-Committee to consider items
    relating to children affected by domestic violence and the Children and
    Adolescent Mental Health Service (CAMHS)subject any additional meetings
    that may be required to consider urgent NHS issues such as formal
    consultations
