Applicant: Miss Melissa Chu

Location: On the footway outside 75-77 Church Street, Croydon, CR0 1RH

Measurements: The measurement from the shop window to the edge of the pavement is 2.74 m narrowing to 2.55m.

The applicant has applied for a trading area of 0.74 m narrowing to 0.55m, which leaves a clear pavement width of 2m.

Church Street is maintained by Croydon Council and the required clear pavement width is 2 m.

A length of 4 m and a height of 1.5 m are also applied for.

1. Detailed Considerations

1.1 The application was received by the Planning & Environment Department on 27 July 2012.

A copy of the application is attached as Appendix A4.

1.2 The application was duly advertised in the Croydon Guardian, no objections were received.

1.3 The Police licensing Officers, Food Safety team, Planning, Highways, and parking services divisions were invited to comment on this application, no objections have been received.

1.4 The measurements outlined above have been checked and agreed by an Enforcement Officer during a site visit.

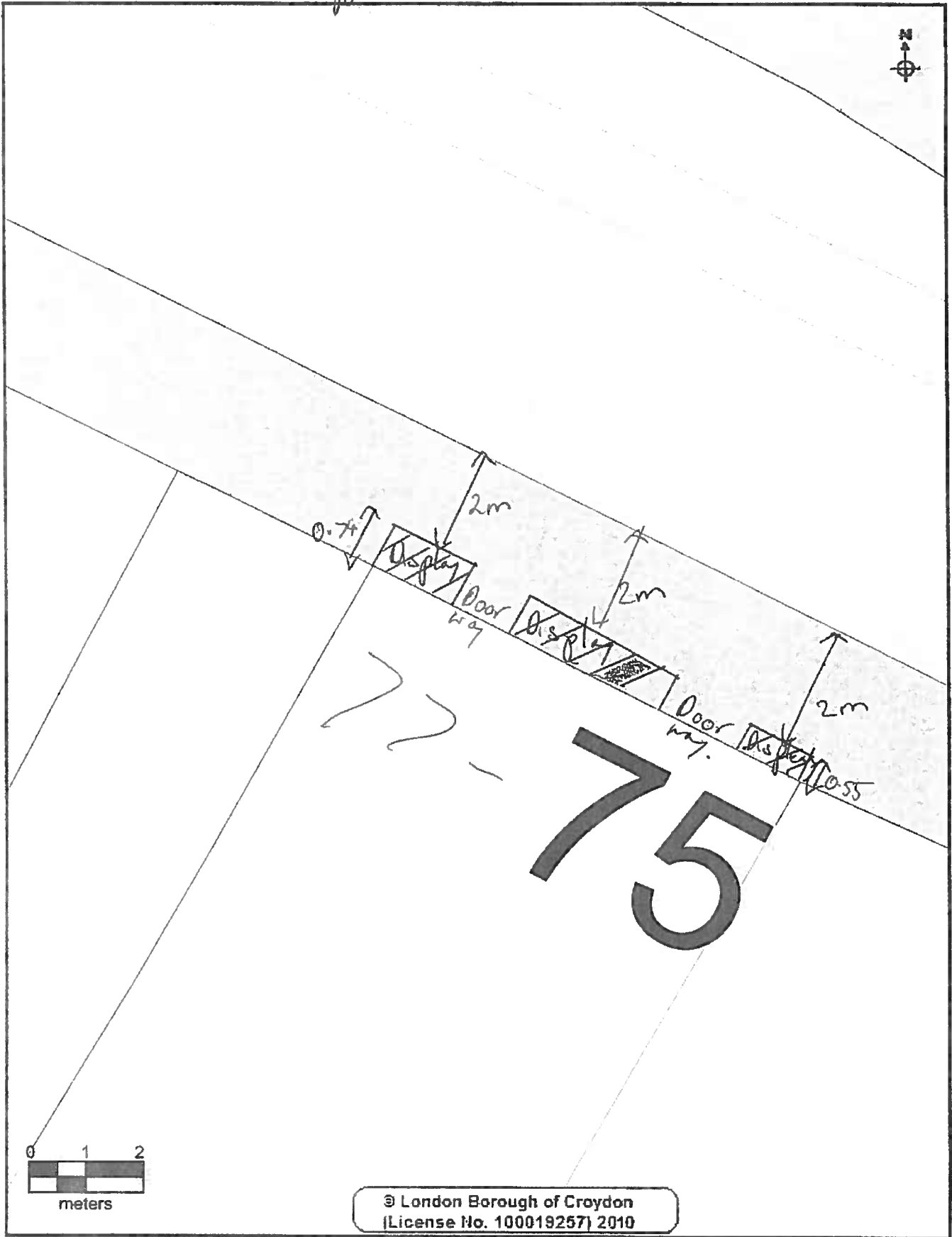
1.5 A temporary licence was issued to the applicant which is valid until the 27.1.2013 pending the committee's decision. A copy is attached as Appendix A5.

- 1.6 There are 8 other nearby premises in Church Street who currently hold a street trading licence. No 40 clothing, 42 tables and chairs, 50-52 footwear, 65 tables and chairs, 76-78 furniture etc, 92 household goods, 98 tables and chairs, 103 household goods.

The position of these sites are marked with a * and the site applied for is shaded on the attached map Appendix A6.

- 1.7 If the application for a street trading licence is granted the applicant will be invited to apply for a Street Trading Licence which will then be valid for a year
