
1.1 The application was received by the Planning & Environment Department on 28 May 2013.

- 1.3 The Police licensing Officers, Food Safety team, Planning, Highways, and parking services divisions were invited to comment on this application, no objections have been received.
- 1.4 The measurements outlined above have been checked and agreed by an Enforcement Officer during a site visit.
- 1.5 A temporary licence was issued to the applicant which is valid until the 19.1.2014 pending the committee's decision. A copy is attached as Appendix A4.
- 1.6 There are 5 other nearby premises in the High Street who currently hold street trading licences. No's 16 Tiger Tiger, 16 Milan Bar, 26, 36 and 38-40 all the sites are licensed to display tables and chairs. The position of these sites








Licence Conditions

Non Transport for London Maintained Roads
