1.1 The application was received by the Development & Environment Department on 21 August 2014.


A copy of the application is attached as Appendix E4.

- 1.5 A temporary licence was issued to the applicant which is valid until the 21.2.2015 pending the Committee's decision. A copy is attached as Appendix E5.
- 1.6 There are 2 other nearby premises in Brighton Road who currently hold a street trading licence: 944- tables and chairs and 950 tables and chairs.

These sites are marked with an x and the site applied for is shaded on the attached map Appendix E6.

1.7 If the application for a street designation order is granted the applicant will be invited to apply for a Street Trading Licence which will then be valid for a year.








Licence Conditions
