

## APPENDIX C

**Applicant:** Peter Goatley

**Location:** On the footway outside The George P/H, 17-21 George Street, Croydon, CR0 1LA.

**Measurements:** The application seeks a trading area of 5 metres in length and 1.8 metres in width on the left hand side and a length of 4 metres and a width of 1.8 metres on the right hand side of the entrance to the premises. There is a minimum clear pavement width of 2 metres from the edge of the proposed display to the kerb or any item of street furniture on George Street on the LHS and a minimum of 2.2 metres on the RHS. This section of highway is maintained by Croydon Council and the minimum required clear pavement width is 2 metres.

Would the committee please note that this site has been previously designated for street trading (provision of tables & chairs) and there is an existing street trading licence in place. A copy is attached at Appendix C1.

This application seeks an enlarged designated area by increasing the designated area in length on the LHS. A copy of the application is attached at Appendix C2. This includes diagrams provided by the applicant showing the existing and proposed layout.

The premises are not currently providing any tables & chairs, even though they have a temporary street trading licence for the proposed new dimensions (pending the committee's decision) and an existing full street trading licence for the current dimensions. There are therefore no photographs of the display in situ for this report.

### **Proposed Times of Trading:**

Monday to Sunday 0800 hours until midnight

**To Provide/Sell:** Provision of tables & chairs for customers

#### **1. Detailed Considerations**

- 1.1 The application was received by the Place Department on 17 November 2016.
- 1.2 The application was duly advertised in the Croydon Guardian, no objections were received.

- 1.3 The Police Licensing Officer, Food Safety team, Planning, Highways and Parking Services divisions were invited to comment on this application, no objections have been received.
- 1.4 The measurements outlined above have been checked and agreed by an Enforcement Officer during a site visit. A diagram of the site is attached at Appendix C3.
- 1.5 A temporary licence was issued to the applicant which is valid until 17.05.2017 pending the committee's decision. A copy is attached as Appendix C4.
- 1.6 There are 4 other nearby premises who currently hold a street trading licence. These are 11b George Street (display of household goods), 18 (provision of tables & chairs), 27 (display of stationery) and 28 (display of stationery). These are marked on map at Appendix C5 and the application site is marked X.
- 1.7 If the application for a street designation order is granted the applicant will be invited to apply for a new Street Trading Licence which will then be valid for a year

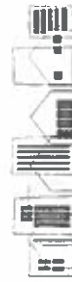

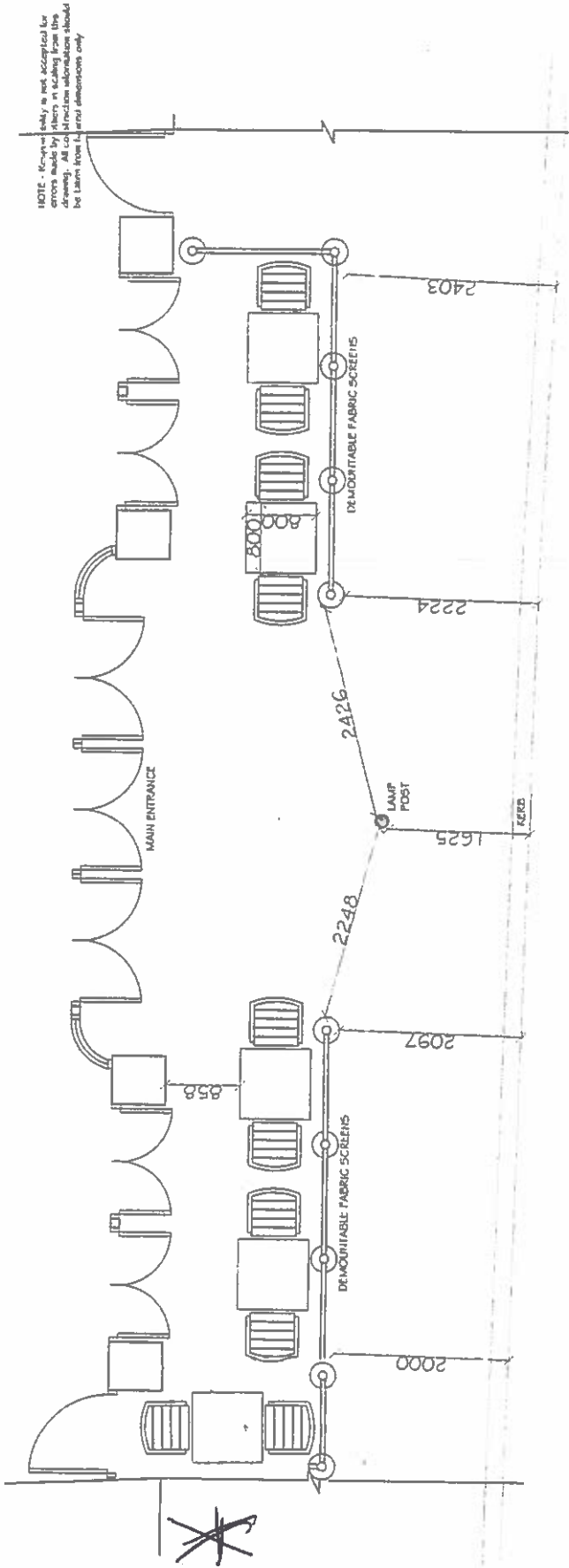
PLAN AS EXISTING
