### Background:

Recent encampments by Travellers in the borough identified what appeared to be a lack of understanding of Traveller community needs and a lack of coordination by public bodies on how to respond to unauthorised encampments. There appears to be a one size fits all approach to a community of communities which is not homogenous.

## Lines of Enquiry:

#### To:

- a) Review current policies and mechanisms (including legislation) for managing issues related to the Travelling Community(ies) including the Croydon Unauthorised Encampment Policy (April 2013);
- b) Consider the roles and responsibilities of each agency involved including the powers and duties that exist and who holds those powers;
- c) Review best practice (including a possible visit) around matters relating to the coexistence of the Travelling Community and local residents'
- d) Gather evidence from interested groups, including travellers (see below); and
- e) Review the progress (challenges and barriers) in identifying sites within the borough in relation to delivering **SP2.7** which states that the Council will seek to deliver ten additional Gypsy and Travellers pitches in the borough by 2021 to meet the need of Croydon's Gypsy and Traveller community and that this will be achieved by allocating land for Gypsy and Traveller pitches in the Croydon Local Plan: Detailed Policies and Proposals DPD.

## Possible questions:

- a) What do travellers need when they visit Croydon and why do they use certain spaces?
- b) What provision do we offer and what do we need to do to improve the provision?
- c) What other needs do Travellers have when they visit Croydon and does the Council and its partner organisations fulfil these?
- d) What do other local authorities offer and what can Croydon learn from best practice?
- e) Why do unauthorised encampments occur and what are our procedures for removing unauthorised encampments?
- f) How can we create a relationship with the Travelling community (ies) so we can prevent unauthorised encampments?
- g) What are the different traveller communities and how can this insight help in working with traveller communities?
