The Cabinet **RESOLVED**:

- 1.1 To note the demand update and the Council's success in securing £63M over two years from the DfE towards the estates programme.
- To note the outcomes of the consultations regarding proposals to establish by September 2014, *a new primary school in South Croydon*, (*Haling Road*); and a new secondary school in South Norwood Arena/CALAT- sites and agree to proceed to the feasibility stage application for planning permission and development of detailed design plans to establish those schools.
- 1.3 To agree to the proposed supply strategies for the 2014-15 and 2015-16 education years and proceed with a statutory consultation for permanent expansions and new schools as follows:
 - Permanent expansions at Kingsley
 - New schools on the following sites: site adjacent to Spices Yard, Westways House, 843 London Road, Victoria House, SeGAS House, and a site near to West Thornton Primary Academy*.
- 1.4 To delegate to the Cabinet member for Children, Families and Learning (CFL) and the Executive Director for CFL the decision, in the light of the first stage of statutory consultation, on whether to publish statutory notice for the permanent school expansion and the final number and placing of bulge classes needed.
- 1.5 To note that the Leader has delegated the decision to the Lead Memberto proceed with the consultation on establishing a resource base forpupils with aspergers syndrome at Courtwood Primary School for Sept2014, and depending on the results, to proceed to statutory notice (oneof the provisions agreed in principle through the July 2011 Cabinetreport on provision for pupils with special educational needs).

The undersigned are only calling in those parts of the recommendations that are not struck through. The part of the recommendations that are being called in are:

- 1.6 To note the demand update and the Council's success in securing £63M over two years from the DfE towards the estates programme.
- 1.7 To note the outcomes of the consultations regarding proposals to establish by September 2014, a new secondary school in South Norwood Arena/CALAT- sites and agree to proceed to the feasibility stage application

- 1.8 To agree to the proposed supply strategies for the 2014-15 and 2015-16 education years and proceed with a statutory consultation for permanent expansions and new schools as follows:
 - New schools on the following sites: site adjacent to Spices Yard,
 Westways House, 843 London Road, Victoria House, SeGAS House, and
 a site near to West Thornton Primary Academy*.

- To understand where in Croydon school places are needed at both primary school level and secondary school level.
- To understand the justifications why each proposed site was chosen.
- To understand the implications for Council's capital and revenue budgets
- To give local communities a voice the setting up if proposed new schools
- To assess whether the proposed sites are the best sites available for new school places

Information required to assist the Scrutiny and Strategic Overview Committee to consider the referral:

- 1)Information on where in Croydon is the greatest demand for primary and secondary school places
- 2)Explanation for the growth in pupil numbers
- 3)Information on all possible school sites, both council and non-council owned, and why they weren't considered
- 4)List of all Council owned land which are of a size to hold either a primary or secondary school
- 5)Update from a planning officer on the planning issues regarding Arena/CALAT, site adjacent to Spices Yard, Westways House, 843 London Road, Victoria House, SeGAS House, and a site near to West Thornton Primary Academy*.
- 6)Review of the accuracy of the forecasts made in the Education Estates Needs Analysis reported to Transforming Croydon Schools (TCS) Sept 2010
