#### 8/17 Minutes of the Previous Meeting

In consideration of the minutes of the meeting held on 23 November 2017, it was specifically asked by Members as to whether there was a transcript of the previous committee business and the Committee noted that full transcripts of committee meetings were not taken. It was and felt that a more detailed record of the meeting would have been beneficial. Following discussion, and subject to the addition of a note within the minutes that Members would have preferred the detail contained within the minutes relating to item 6 to be more fulsome given the length of discussion, the Committee put the accuracy of the minutes to the vote and they were confirmed as an accurate record of the meeting.

## 11/17 London Local Authorities Act 1990: Applications for Street Designation Orders

The Committee considered an application for a street designation order and street trading licence for Milan Bar, 14-32 High Street as detailed in appendix A to the report.

The Licensing Manager introduced the application, detailing the process for making street designation orders and the details of the application. The Committee was informed that responsible authorities had been notified of the application and that it had also been advertised in the local press. No objections had been received.

In response to a question from the committee, the Licensing Manager confirmed that smoking would be permitted in the area covered by the proposed order.

The applicant was present and offered to answer any further questions from Members.

#### The Committee **RESOLVED**:

- To designate the specified area outside Milan Bar, 14-32 High Street for the purposes of street trading; and
- 2 To grant a street trading licence to the Applicant.

The Committee considered an application for a street designation order and street trading licence for **1451 London Road** as detailed in appendix B to the report.

The Licensing Manager introduced the report and summarised the application, highlighting that no objections had been received during the consultation process. The Committee heard that while the application fell within a 'saturation area', the application was still to be considered upon its own merits.

The Committee noted that under the temporary licence, the applicant had not put a barrier in place and that the existing arrangement for tables and chairs left little room for a barrier. The Licensing Manager informed the Committee that the applicant would be required to place a removable barrier around the area should a licence be granted and that this would not be allowed to exceed the area specified in the application.

In response to questions from Members, the Committee received confirmation that the consultation process had allowed time for responses from Transport for London and Ward Councillors.

The applicant was not present for consideration of the applications.

#### The Committee **RESOLVED**:

- To designate the specified area outside 1451 London Road for the purposes of street trading; and
- 4 To grant a street trading licence to the Applicant.

The Committee also considered an application for a street designation order and street trading licence for the **Market Tavern Public House**, **1-4 Surrey Street** as detailed in appendix C to the report.

The Licensing Manager introduced the report and summarised details of the application. The Committee heard that the applicant had initially sought hours of 7.00am to 11.00pm Monday to Sunday. Following receipt of objections from local residents to those proposed hours, the application had been amended to seek operating hours of 9.00pm Monday to Sunday for street trading purposes. The revised operating hours for street trading under this application for a license had been shared with objectors and all objections had been subsequently withdrawn.

In response to questions, the Committee heard that residents would have further opportunities to raise any objections as the licence would be renewed annually and that the dropped kerb layout of the area was similar in nature to other designated areas in South End.

Representatives of the applicant were present and informed the Committee that outdoor heating would be considered if the licence were to be granted.

#### The Committee **RESOLVED**:

- To designate the specified area outside the Market Tavern Public House, 1-4 Surrey Street for the purposes of street trading; and
- 6 To grant a street trading licence to the Applicant.

The Committee considered an application for a street designation order and street trading licence for **Dingwall Road Footway** as detailed in appendix D to the report.

The Licensing Manager introduced the report and summarised details of the application. The Committee heard that an objection had initially been received from Croydon BID but had been subsequently withdrawn following cosmetic improvements to the trading kiosk.

The Licensing Manager also informed Members that the site fell within the area for a the proposed extension to the tram network and highlighted that a designation order for the site would subsequently need to be de-designated should that extension to the tram network go ahead. In the alternative, the Licensing Manger informed the Committee that the granting of a six month temporary licence could be considered, with further six month renewals dependent upon the status of the tram extension works.

The applicant was present at the meeting and informed Members of the history of the kiosk business. Following questions from Members, the applicant confirmed that a rolling six month temporary licence would be

acceptable and that they would consider alternative sites if the extension to the tram network took place.

Following further questions from the Committee, the Licensing Manager confirmed that there would be no additional costs to the applicant by granting six month temporary licenses rather than a twelve month licence.

#### The Committee **RESOLVED**:

- 7 To not designate the specified area on Dingwall Road Footway for the purposes of street trading;
- 8 To grant a six month temporary licence to Mr Rivero to undertake street trading at the specified area on Dingwall Road Footway; and
- 9 To delegate decision making on future applications for any further six month temporary licenses from Mr Rivero at this site to the Licensing Manager.

#### 12/17 Review of Statement of Licensing Policy

Further to Licensing Committee Minute Number 5/17, Review of Statement of Licensing Policy, the Committee considered a report that detailed proposals for a revised Licensing Policy and the outcome of consultation on those proposals.

The Cabinet Member for Communities, Safety and Justice, Councillor Hamida Ali, was invited to introduce the report in conjunction with the Licensing Manager.

The Committee heard that the report was unchanged from the report it considered at its meeting on 23 November 2017. There remained two key proposed changes to the policy, namely the removal of the special town centre cumulative impact zone (CIZ) and the removal of reference to the Metropolitan Police Service's Promotion Event Risk Assessment Form 696.

The Committee further heard that the removal of the town centre CIZ was a reflection on the significantly changed evening and night time economy in the Town Centre since it was first introduced in 2004. Members also heard that the specific references to Form 696 had been removed to allow for a broader provision in relation to the risk assessment, incorporating not only crime and disorder but also public safety. In addition, this proposed change by the Authority was timely as the Metropolitan Police Service had recently subsequently taken the decision to withdraw the Form from use following a review of its use. The proposed policy had replaced these references with broader terminology relating to risk assessment duties before events were held.

The Committee had previously deferred decision making on the proposed policy in order to seek legal advice on whether an unpublished Scrutiny Sub-Committee report on the Night Time Economy should be considered as part of the decision making process. Members were informed that the process was

for the Scrutiny Sub-Committee to formally consider its draft report and make any recommendations to the Scrutiny Committee, who in turn would make any onward recommendations. The Scrutiny Sub-Committee's report was still an unpublished draft document that was yet to be considered by the Sub-Committee and was not a matter for consideration by the Licensing Committee.

Following questions from Members, the Committee heard that the Town Centre CIZ had not been invoked since the policy was last reviewed and that applications would still be put before the Licensing Sub-Committee for consideration if relevant representations were received.

The Committee also noted that any future consultation on the Licensing Policy would include the Greater London Authority representative.

In consideration of section 6.6 of the proposed policy, the Committee noted that an erroneous reference had been made to the Traffic Management Cabinet Committee. The Committee requested that this section be amended to correctly reflect the roles of the Traffic Management Advisory Committee and the Public Transport Liaison Panel.

#### The Committee **RESOLVED**:

That subject to the amendment of section 6.6 of the report to correctly reflect the roles of the Traffic Management Advisory Committee and the Public Transport Liaison Panel, to recommend the adoption of the revised Licensing Policy to the next available ordinary meeting of the Full Council.

The Sub-Committee **RESOLVED** to appoint Councillor Avis as Chair of the Sub-Committee.

### 4/18 Licensing Act 2003: Review of Premises Licence

The Licensing Sub-Committee considered the application for a Review of the Premises Licence at Club 34, Surrey Street, CR0 1RJ and the representations by the Police as contained in the report of the Executive Director 'Place'. The Sub-Committee also considered the additional documentation provided by the Police in support of the application, and the verbal representations made at the hearing by the Police's Counsel.

The Sub-Committee further considered the representations from the premises licence holder contained in the respondent's bundle and the verbal representations made at the hearing by the premises licence holder's counsel.

The Sub-Committee were additionally given notice that an agreed set of conditions had been made between both parties, and the Sub-Committee were provided a copy of the agreement prior to the meeting.

The Sub-Committee considered whether taking any of the following steps were necessary to promote the four licensing objectives:

- To modify the conditions of the licence
- To exclude a licensable activity from the scope of the licence
- To remove the designated premises supervisor
- To suspend the licence for a period not exceeding 3 months
- To revoke the licence

The Sub-Committee, having reference to the licensing objectives under the Licensing Act 2003 and the Council Licensing Policy **RESOLVED** to modify the conditions of the license for the promotion of the licensing objectives.

The Sub-Committee was persuaded that the modifications to the conditions would provide adequate assurances towards the promotion of the licensing objectives and were appropriate and proportionate in the circumstances.

The modifications to the licence were as follows:

- 1. Kevin Bond shall be removed as the Designated Premises Supervisor and shall not act in that capacity at any time.
- 2. Kevin Bond shall not be involved in the day to day management of licensable activities at the premises at any time.
- A new experienced DPS shall be employed whose details shall be provided to police for approval in advance of submitting a DPS variation.
  - [To replace existing conditions 3-5 of Annex 2]
- 4. A minimum of 2 door supervisors shall be deployed at the venue on a Thursday, Friday, Saturday, Christmas Eve, New Year's Eve, bank holidays and Sundays before a bank holiday from 2000hrs or from the time that the venue opens for Regulated Entertainment if it is after 2000hrs.
- 5. A minimum of 4 door supervisors, in which 1 must be a female door supervisor, shall be deployed at the venue on a Thursday, Friday, Saturday, Christmas Eve, New Year's Eve, bank holidays and Sundays before a bank holiday from 2200hrs or from the time that the venue opens for Regulated Entertainment if it is after 2200hrs
- 6. Additional door supervisors (one of which must be a female door supervisor) shall be deployed as required on a Thursday, Friday, Saturday, Christmas Eve, New Year's Eve, bank holidays and Sundays before a bank holiday so that there is at least 1 door supervisor to 50 customers.

[To replace existing condition 11 of Annex 2]

- 7. From 2000hrs on Thursday, Friday, Saturday, Christmas Eve, New Year's Eve, bank holidays and Sundays before a bank holiday, all drinking vessels, glasses and bottles provided to customers at the premises shall be polycarbonate.
- 8. No members of the public are to be admitted or re-admitted to the premises after 2000hrs unless they have undergone a search procedure including the use of metal detecting arch.

[To replace existing conditions 13 of Annex 2]

- 9. Ensure that no members of the public are admitted to the premises after 01:00hrs save for the re-admission of customers who have left the premises temporarily to smoke.
- Subject to any fire risk assessment, the door at the junction of Surrey Street and Bell Hill will not be used as a fire escape or final exit door and will be kept locked shut and alarmed.

[To replace existing conditions 28 of Annex 2]

- 11. An identification scanning device capable of recording and checking identity documents must be in use at the premises from 2100hrs on Thursday, Friday and Saturday nights, Christmas Eve, New Year's Eve, bank holiday and Sundays before a Bank Holiday (and on other occasions the use of the Id Scanner is to be risk assessed). All customers must have their ID scanned as a condition of entry. IDs must be valid and in date. The following are acceptable forms of identification:
  - a. Passports
  - b. National identity cards
  - c. Driving licences
  - d. Military ID cards
  - e. Cards bearing the PASS hologram
- From 22:00 on a Thursday, Friday and Saturday the premises licence holder shall designate a member of staff for the purposes of customer welfare.
- 13. Only the DPS may confirm bookings of the venue for externally promoted events.
- 14. The sale of alcohol shall terminate at 02:30hrs.
- 15. The provision of late night refreshment and regulated entertainment shall terminate at 03:00hrs.
- 16. The premises shall close to the public at 03.00hrs.

As required under the Licensing Act 2003, as amended, the Sub-Committee considered the decision taken during the summary review held on 22

December 2017. Following deliberations and consideration of the facts of the application, it was agreed that the summary review decision suspending the premises licence from 05:00 on 2nd January 2018 be removed and the modifications agreed take effect from 17 January 2018.

# 5. Application for Review of a Premises Licence: 247 London Road, Croydon, CR0 2RL

The Licensing Sub-Committee considered the Application for a Review of the Premises Licence at 247 London Road, Croydon, CR0 2RL and the representations received as contained in the report of the Executive Director

'Place'. The Sub-Committee also considered the verbal representations made by the police at the hearing and the additional documentation submitted in advance of the hearing.

The Sub-Committee also considered the verbal representations made at the hearing by the premises licence holder and his representative. The CCTV engineer and an illegal worker from the premises was also present to answer questions on behalf of the premises license holder.

The Sub-Committee considered whether taking any of the following steps were necessary to promote the four licensing objectives:

- To modify the conditions of the licence
- To exclude a licensable activity from the scope of the licence
- To remove the designated premises supervisor
- To suspend the licence for a period not exceeding 3 months
- To revoke the licence

The Sub-Committee, having reference to the licensing objectives under the Licensing Act 2003 and the Council Licensing Policy **RESOLVED** to **REVOKE** the premises license on the basis that the Sub-Committee was satisfied that it would support the licensing objectives to do so for the following reasons:

- 1. Having regard to the police's stepped approach to address concerns with the premises and the fact that this has not resulted in satisfactory compliance with the licensing objectives and the licensing conditions.
- 2. Concerns in relation to immigration offences as detailed in the statements by the police including a repeat instance of employing an illegal worker in the premises in November 2017. In this regard, the Sub-Committee had specific reference to the Statutory Guidance: Paragraph 11.18 in relation to taking into account any civil immigration penalties which the license holder has been required to pay for employing an illegal worker. In addition, the Sub-Committee had regard to Paragraph 11.27 namely that there is certain criminal activity that may arise in connection with licensed premises which should be taken particularly seriously. This includes use of licensed premises for employing a person who is disqualified from that work by reason of their immigration status in the UK.
- 3. Following variation of the license to incorporate additional conditions on the 10<sup>th</sup> October 2017 the compliance with the conditions on the premises licence has not improved satisfactorily in that, subsequent to the variation, the premises license holder has failed to comply with a number of conditions including:
  - Condition 1: Permitted hours of sale of alcohol.
  - Condition 4: In relation to CCTV to Home Office requirements, its maintenance, retention and provision of images in usable format to the police, and ensuring that the system covers all internal and external areas (including where alcohol is displayed/sold).

- Condition 8: Failure to ensure that the staff are trained by the Croydon Council Trading Standards in aged restricted products.
- Condition 10: Insufficient proof of identification and Right to Work documentation of persons working on the premises.
- Condition 11: That each alcohol sale shall only be made by a personal license holder.
- 4. Concern that the current premises license holder did not understand and would therefore have difficulty in applying the licensing objectives.

In particular, the sub-committee noted that the applicant has submitted revised conditions which he proposes to be attached as further conditions to the premises license.

#### 1. RECOMMENDATIONS

1.1 The Committee is asked to determine whether to designate the sites detailed at Appendix A - F for the purposes of street trading and if designated to then determine whether to grant a street trading licence to the site.

#### 2. EXECUTIVE SUMMARY

2.1 The purpose of this report is to seek the Committee's decision on the proposal to designate six sites in the Borough as 'licence streets for street trading and the granting of street trading licences under the provisions of the London Local Authorities Act 1990 (as amended.)

#### 3. DETAIL

- 3.1 The London Local Authorities Act 1990 (as amended) (The Act) provides a legislative framework to control street trading in the Borough. Trading in respect of services as well as goods comes within the scope of the Act.
- 3.2 Licensed street trading may only take place in streets or parts of streets which have been formally designated as "licence streets".
- 3.3 Appendices A-F to this report provide details of the designation applications. The applicants have been invited to attend the meeting.
- 3.4 If the sites outlined in Appendices A-F are formally designated as 'licence streets by the committee then the committee will decide whether to grant street trading licences
- 3.5 The measurements of the individual display areas as outlined in Appendices A-F will allow for the required 2 metre clear distance between the edge of the display and the kerb which is the requirement for roads maintained by Croydon Council or the required 2.8 metre clear distance for roads maintained by Transport for London (TfL), whichever is applicable.

#### 4. CONSULTATION

4.1 Applications A–F were duly advertised in the Croydon Guardian and brought to the attention of the police, planning, highways, parking services and the food & safety team.

#### 5 FINANCIAL AND RISK ASSESSMENT CONSIDERATIONS

#### 5.1 The effect of the decision

There are no direct financial implications as a result of this report.

#### 5.2 Risks

If an applicant is refused a licence on any of the grounds mentioned in paragraph 7.2 (a) - (g) he/she will have the right of appeal to the Magistrates' Court against the decision. The decision of the Committee may also be subject to Judicial Review.

An appeal against a decision of the Committee or a Judicial Review of the application process may present financial risks to the Council with regard to any award of costs against it.

#### 6. COMMENTS OF THE SOLICITOR AND MONTORING OFFICER

#### LICENCE STREET

- 6.1 If the borough council considers that street trading should be licensed in an area, they may pass a resolution designating any street within the borough as a "licence street" in accordance with Section 24 of the Act.
- 6.2 The first decision which has to be made is whether to designate the particular location as a "licence street", which in turn would permit the consideration of a licence application.
- 6.3 Under Section 24 of the Act, the designation of a location as a "licence street" is at the discretion of the Committee and this decision is not subject to any direct appeal.
- 6.4 Each application must be considered on its own merits.

#### 6.5 STREET TRADING LICENCE

If a site has been designated as a 'licence street', the committee must then decide whether to grant a licence to trade at that site – a 'street trading licence'.

#### 7. GROUNDS FOR REFUSAL

- 7.1 Under Section 25(4) of the Act, a street trading licence:
  - (a) shall not be granted:
  - (i) to a person under the age of 17 years; or
  - (ii) except where the application is made by a company incorporated under the Companies Acts, or by a partnership, for a licence to carry on ice- cream trading to a person, on a corresponding day, days or time, who holds a street trading licence in any other licence street granted under this Part of the Act but nothing in this paragraph shall prevent the renewal of such a licence; or

- (iii) except where the application is made by a company incorporated under the Companies Acts, or by a partnership, for a licence to carry on icecream trading to a body corporate or to an unincorporated association;
- (iv) in respect of an application for a licence which is not a temporary licence to trade in a street which is not a licence street; or
- (v) where the street to which the application relates is a street in respect of which the borough council have by resolution passed under Sub-Section 1) (b) of Section 24 of this Act, specified a class of articles or things, or services which they will not prescribe in any street trading licence and the grant of the licence would be contrary to any of the terms of that resolution;
- (b) shall not be granted unless the borough council are satisfied that there is enough space in the street for the applicant to engage in the trading in which he desires to trade without causing undue interference or inconvenience to persons or vehicular traffic using the street.
- 7.2 Under Section 25(6) of the Act, the Council may refuse an application on any of the following grounds:
  - (a) that there are enough traders trading in the street or in any street adjoining the street in respect of which the application is made in the goods in which the applicant desires to trade;
  - (b) that the applicant is on account of misconduct or for any other sufficient reason unsuitable to hold the licence;
  - (c) that the applicant is an individual who has without reasonable excuse failed personally to avail himself of a previous street trading licence;
  - (d) that the applicant has at any time been granted a street trading licence by the borough council which was revoked or could have been revoked on the grounds that he had refused or neglected to pay fees or other charges due to them in respect of the licence;
  - (e) that the applicant has failed to provide or to identify suitable or adequate premises for the storage of any receptacles or perishable goods in which he proposed to trade when street trading is not taking place;
  - (f) that the application is for the grant (but not the renewal) of a street trading licence; and
    - (i) the only available position is in that part of the street which is contiguous with the frontage of a shop; and
    - (ii) the articles, things or services mentioned in the application are sold or provided at the shop;

- (g) that
  - (i) the application is for the grant (but not the renewal) of a street trading licence; and
  - (ii) the only available position in the street is within the curtilage of a shop; and
  - (iii) the applicant is not the owner or occupier of the premises comprising the shop.

- The right to a hearing within a reasonable time.
- 13.2 When hearing an application, the proceedings of a non-judicial body such as the Licensing Committee, as opposed to an actual Court, need not meet the full requirements of A6 where there is a right of appeal from the Licensing Committee to a Court that <u>does</u> meet the full A6 standards <u>and</u> can consider all aspects of the case (even if that does not include a full re-hearing of the facts).
- 13.3 So, while it is good practice to make a hearing before the Licensing Committee as A6 compliant as possible, it will not be a breach of the HRA if it is not. Further, the hearing of all applications are subject to the principles of Natural Justice and the requirement for decisions to be 'Wednesbury reasonable'.

### **Licence Conditions**

### Non Transport for London Maintained Roads

- 1. The Licence shall ensure that there is a minimum clear passage of **2.0 metres** between the front edge of their display and the edge of the kerb or any item of street furniture (railings/lamp posts etc) whichever is the nearer to the display
- 2. A clear copy of the licence shall be displayed in the front window of the premises at all times and should be visible to passers by.
- 3. Please note that the person named on the licence and whose photograph appears on the licence is responsible for the premises at all times. This licence may not be transferred to any other person.
