8/19 **Minutes of the Previous Meeting**

The minutes of the meeting held on 24 January 2019 were agreed as an accurate record.

11/19 **Application for Street Designation Order - London Local Authorities Act 1990**

The Committee considered the application for a street designation order for **32-34 High Street, Thornton Heath, CR7 8LE** (Appendix A).

The Licensing Manager introduced the item, explaining the process of designation for street trading and applying for street trading licences and the details of the application before the Committee. It was said that the premises was also within the saturation area.

The applicant was not present to provide any comment on the application.

Councillor Bird arrived to the meeting at approximately 6.39pm.

In response to questions from the Committee it was confirmed by the licensing manager that the Committee had previously deferred this application (21 November 2018) in order to enable the applicant to attend and make representations and then refused it following consideration at the deferred hearing (19 December 2018). The applicant was invited to attend each Committee but was not present when these decisions were made.

It was noted that there were 8 premises nearby on Thornton Heath High Street which were currently designated for street trading. In order to ensure premises as well as those operating with temporary licenses were not encroaching on the pavement or exceeding the designated (or proposed) area, officers do carry out checks across the borough and review whether they are adhering to the agreed conditions and parameters.

Members expressed concern about the granting of temporary licenses within a saturation zone pending consideration by the Full Committee, which could exacerbate existing concerns in those areas around the ability of users to safely navigate the pavements. Members asked officers to consider the matter and bring a future report to the Committee for consideration regarding potential solutions to these concerns.

Following discussion of the application in question by Members.

The Committee **RESOLVED**:

To refuse to designate 32-34 High Street, Thornton Heath for the purposes of street trading on the basis that the proposed site was within the saturation zone and the Committee was of the view that any addition to the number of existing designated sites would have an overall detrimental impact on the safe and convenient passage of pedestrians in that part of the street. It was accordingly unnecessary to consider whether or not to grant or refuse a street trading license to the Applicant at this site.

12/19 **Rescinding Designation of Licensed streets/parts of streets - London Local Authorities Act 1990**

The Licensing Manager presented the report to the Committee. The Licensing Manager explained the purpose of the report and the provisions of the London Local Authorities Act 1990.

The Licensing manager then addressed Members on the proposed recommendations as set out in Section 1 of the Report. The sites which were recommended for de-designation were listed in Appendix 1.

The Chair invited members' questions on the report and presentation.

The Committee heard that these sites were previously designated and were being suggested for de-designation because they were not being used by

traders. It was stated that no existing traders would lose their right to trade from those areas if the Committee approved the recommendations.

The Committee **RESOLVED** to agree to the recommendations of the report and give notice of its intention to rescind the designation of the sites listed at Appendix 1 to this report under the London Local Authorities Act 1990.

13/19 **Revision to Standard Licensing Conditions for Premises offering Special Treatments - London Local Authorities Act 1991**

The Licensing Manager was invited by the Chair to present the report to the Committee. The Licensing Manager explained the purpose of the report and the provisions of the London Local Authorities Act 1991 ("The Act").

The Licensing manager then addressed Members on the proposed recommendations as set out in Section 1 of the Report.

Members were referred to Appendix 1, the Standard Licensing Conditions for Premises offering Special Treatments, which were previously approved in 2004 and reviewed in 2011. There are a range of treatments offered under the definition of "special treatments", many of which have emerged since the Act was written and therefore the Act does not list them all. There are currently 156 licensed special treatment premises in the borough and a current list of special treatments is listed in Appendix 2 of the report.

The Chair invited members' questions on the report and presentation.

The Committee heard that the training and hygiene of staff needed to be to a high standard for special treatment premises to be fit for business. Some of the amendments to the standard conditions included premises' providing documentation, to prove staff were qualified for the job and named operatives on licenses for those performing the treatments. It was also stated that having the correct information of customers' age and health was important to ensure treatments were safe and lawful.

Councillor Neal arrived to the meeting at approximately 7.15pm.

The Committee **RESOLVED** to agree the recommendations of the report relating to the revised/updated 'Standard Conditions for Places offering Special Treatments' under the London Local Authorities Act 1991.

14/19 **Special Treatments Licensing Fee Setting - London Local Authorities Act 1991**

The Licensing Manager was invited by the Chair to present the report to the Committee. The Licensing Manager explained the purpose of the report and the provisions of the London Local Authorities Act 1991.

The Licensing Sub-Committee considered the Application for a Premises Licence at **58-60 Westow Hill, Upper Norwood, SE19 1RX** and the representations received as contained in the report of the Executive Director 'Place'.

The Sub-Committee also considered further representation submitted by another person within the relevant period but which was not added as part of the report.

The Sub-Committee also considered the verbal representations made at the hearing by the applicant for the premises licence and the oral representations by a resident and written representatives of other objectors to the application.

The Applicant has agreed the following amendment to their Application:

- 10am – 1pm (Saturdays)
- No deliveries or collections on Sundays

The applicant further agreed that there would be no smoking in the passageway after 9pm and customers smoking will be situated at the front of the premises.

The Applicant has also agreed conditions with the Police.

The Sub-Committee is satisfied that the conditions put forward by the Applicant in the licensing schedule of their application, will enable the Licensing Objectives to be met.

The Sub-Committee, having reference to the licensing objectives under the Licensing Act 2003 and the Council Licensing Policy the Sub-Committee have **RESOLVED** to GRANT the application subject to the following conditions:

1. That provision of Recorded Music will be as follows:
 - 10:00 - 22:30 (Mondays to Wednesday)
 - 10:00 – 23: 30 (Thursdays to Saturday)
 - 10:00 - 22:30 (Sundays)
2. The side passage area will not be used after 21:00 on any day.
3. That ONLY plastics containers will be used outside the premises.

In granting this application the Sub- Committee considered the various steps appropriate to promote the licensing objectives of public safety, public nuisance and prevention of harm to children. The Licensing Sub-Committee believes the conditions imposed are proportionate towards the promotion of the relevant licensing objectives in particular the Sub-Committee notes that objections raised relates to premises situated in other premises and neighbouring boroughs and it would be presumptuous to assume the allegations of noise nuisance relates to the premises.

The Sub-Committee is of the view that the existing regulation of and adherence to the Gambling Commission Guidance and Codes of Practice ensures the Applicant is a responsible operator and that the gambling is conducted in a fair and proper way.

The Sub-Committee noted that the Applicant will have a:

- Think 25 Policy,
- Appropriate staff training in place,
- a self exclusion Scheme and test purchase regime.

The Sub-Committee, have made their decision with reference to the licensing objectives under the Gambling Act 2005, relevant Codes of Practice (issued by the Gambling Commission under section 25 of the Act) and the Council Statement of Principles.

The Sub-Committee did **not** taken into consideration:

- the commercial aspects of the business
- concerns about indirect harm to children, as distinct from their entering the premises and taking part in gambling on-site
- the planning regime or
- personal, moral or ethical views on gambling.

The Sub-Committee **RESOLVED** to Grant this application.

The relevant conditions will be placed on the Licence. This included those suggested by the Police and those mandatory and default conditions specified

by the The Gambling Act 2005 (Mandatory and Default Conditions) Regulations 2007.

The Sub-Committee took the opportunity to remind the Objectors that should you be of the view that the Licensing Objectives are not being promoted or adhered to you should apply for a Review of the Licence.

2. The Premises shall only be used by Members of the Purley Bury Bowling Club and Members of the Purley Bury Croquet Club including their bonafide guests.
3. As agreed by the applicant, the premises shall be operated as a private club.

In granting this application the Sub-Committee focused itself on the steps considered appropriate to promote the relevant licensing objectives raised in the application and did not stray into areas not relevant to the application. In particular, the Sub-Committee note that the issue regarding the covenant contained in the freehold title was raised by the objectors but the Sub-Committee did not consider this issue as it believed this was a private law matter and not relevant for consideration of the application.

The Sub-Committee were of the view that this decision was based on evidence adduced at the hearing including written representations, as the conditions were appropriate for the promotion of the licensing objectives and proportionate to what the Sub-Committee aimed to achieve.

The Sub-Committee, having reference to the licensing objectives under the Licensing Act 2003, the Statutory guidance issued under Section 182 of the Licensing Act 2003 and the Council Licensing Policy **RESOLVED** to REFUSE the application for a personal license for the following reasons:

- The provisions of section 120(7)(b) of the Licensing Act 2003 provide that having regard to the objection notice by the police, the authority must reject the application if it considers it necessary for the promotion of the crime prevention objective to do so;
- The conviction in question is never regarded as being spent and was for serious fraud related offences of conspiracy to defraud and conspire to steal and the committee was not satisfied that it would promote the crime prevention objective to grant the license in the current circumstances;
- Whilst the committee was sympathetic to the applicant's desire to move on and noted the other business interests that the applicant is involved in and the changed personal circumstances, the primary concern for the Committee in relation to whether to grant or refuse a personal license in these circumstances is whether or not rejecting this application would be necessary for the promotion of the crime prevention objective to do so and in the circumstances considered that it was necessary.
- Having regard to the provisions of paragraph 4.24 of the Statutory Guidance which provides as follows: "A number of relevant offences never become spent. However, where an applicant is able to demonstrate that the offence in question took place so long ago and that the applicant no longer has a propensity to re-offend, a licensing

authority may consider that it is appropriate to grant the application on the basis that doing so would not undermine the crime prevention objective,” the committee was not satisfied that the crime prevention objective would not be undermined or that given the nature of the offences, that they occurred so long ago that there was no longer a propensity to re-offend.

In relation to the receipt of the police objections beyond the 14 days and implications as set out in Appendix A and the legal comments section of the report, the Sub-Committee noted the reasons given by the police for the delay were due to an amalgamation of police licensing functions with neighbouring boroughs. The Sub-Committee were of the view that it was appropriate from a public policy perspective to nevertheless consider the application and provide an opportunity for the Applicant to make representations to the Sub-Committee.

1. RECOMMENDATIONS

- 1.1 The Committee is asked to determine whether to designate the sites detailed at Appendices A to F for the purposes of street trading and if designated to then determine whether to grant a street trading licence for each site.

2. EXECUTIVE SUMMARY

- 2.1 The purpose of this report is to seek the Committee's decision on the proposal to designate six sites in the Borough as 'licence streets' for street trading and the granting of a street trading licence under the provisions of the London Local Authorities Act 1990 (as amended).

3. DETAIL

- 3.1 The London Local Authorities Act 1990 (as amended) (The Act) provides a legislative framework to control street trading in the Borough. Trading in respect of services as well as goods comes within the scope of the Act.

- 3.2 Licensed street trading may only take place in streets or parts of streets which have been formally designated as “licence streets”.
- 3.3 Appendices A to F to this report provide details of the designation applications. The applicants have been invited to attend the meeting.
- 3.4 If the sites outlined in Appendices A to F are formally designated as ‘licence streets’ by the committee then the committee will decide whether to grant a street trading licence for each site.
- 3.5 The measurements of the individual display areas as outlined in Appendices A-F will allow for the required 2 metre clear distance between the edge of the display and the kerb or the nearest item of street furniture, which is the requirement for roads maintained by Croydon Council or the required 2.8 metre clear distance for roads maintained by Transport for London (TfL), whichever is applicable.

4. CONSULTATION

- 4.1 The applications were duly advertised in the Croydon Guardian and brought to the attention of the police, planning, highways/TfL (as applicable), parking services and the food & safety team.

5. FINANCIAL AND RISK ASSESSMENT CONSIDERATIONS

5.1 The effect of the decision

There are no direct financial implications as a result of this report.

5.2 Risks

If an applicant is refused a licence on any of the grounds mentioned in paragraph 7.2 (a) - (g) he/she will have the right of appeal to the Magistrates’ Court against the decision. The decision of the Committee may also be subject to Judicial Review.

An appeal against a decision of the Committee or a Judicial Review of the application process may present financial risks to the Council with regard to any award of costs against it.

5.1 Options

The options available are: to grant the application, to vary the application, with or without further conditions, or to refuse the application.

5.4 Future savings/efficiencies

There are no savings or efficiencies arising directly from the recommendations in the report.

6. COMMENTS OF THE SOLICITOR AND MONTORING OFFICER

LICENCE STREET

6.1 If the borough council considers that street trading should be licensed in an area, they may pass a resolution designating any street within the borough as a “licence street” in accordance with Section 24 of the Act.

6.2 The first decision which has to be made is whether to designate the particular location as a “licence street”, which in turn would permit the consideration of a licence application.

6.3 Under Section 24 of the Act, the designation of a location as a “licence street” is at the discretion of the Committee and this decision is not subject to any direct appeal.

6.4 Each application must be considered on its own merits.

6.5 STREET TRADING LICENCE

If a site has been designated as a ‘licence street’, the committee must then decide whether to grant a licence to trade at that site – a ‘street trading licence’.

7. GROUNDS FOR REFUSAL

7.1 Under Section 25(4) of the Act, a street trading licence:

(a) shall not be granted:

- (i) to a person under the age of 17 years; or
- (ii) except where the application is made by a company incorporated under the Companies Acts, or by a partnership, for a licence to carry on ice- cream trading to a person, on a corresponding day, days or time, who holds a street trading licence in any other licence street granted under this Part of the Act but nothing in this paragraph shall prevent the renewal of such a licence; or
- (iii) except where the application is made by a company incorporated under the Companies Acts, or by a partnership, for a licence to carry on ice-cream trading to a body corporate or to an unincorporated association;
- (iv) in respect of an application for a licence which is not a temporary licence to trade in a street which is not a licence street; or
- (v) where the street to which the application relates is a street in

respect of which the borough council have by resolution passed under Sub-Section 1) (b) of Section 24 of this Act, specified a class of articles or things, or services which they will not prescribe in any street trading licence and the grant of the licence would be contrary to any of the terms of that resolution;

- (b) shall not be granted unless the borough council are satisfied that there is enough space in the street for the applicant to engage in the trading in which he desires to trade without causing undue interference or inconvenience to persons or vehicular traffic using the street.

7.2 Under Section 25(6) of the Act, the Council may refuse an application on any of the following grounds:

- (a) that there are enough traders trading in the street or in any street adjoining the street in respect of which the application is made in the goods in which the applicant desires to trade;
- (b) that the applicant is on account of misconduct or for any other sufficient reason unsuitable to hold the licence;
- (c) that the applicant is an individual who has without reasonable excuse failed personally to avail himself of a previous street trading licence;
- (d) that the applicant has at any time been granted a street trading licence by the borough council which was revoked or could have been revoked on the grounds that he had refused or neglected to pay fees or other charges due to them in respect of the licence;
- (e) that the applicant has failed to provide or to identify suitable or adequate premises for the storage of any receptacles or perishable goods in which he proposed to trade when street trading is not taking place;
- (f) that the application is for the grant (but not the renewal) of a street trading licence; and
 - (i) the only available position is in that part of the street which is contiguous with the frontage of a shop; and
 - (ii) the articles, things or services mentioned in the application are sold or provided at the shop;
- (g) that
 - (i) the application is for the grant (but not the renewal) of a street trading licence; and
 - (ii) the only available position in the street is within the curtilage of a shop; and

- (iii) the applicant is not the owner or occupier of the premises comprising the shop.

7.3 The Head of Litigation and Corporate Law comments on behalf of the Director of Law and Governance that there are no additional legal implications arising from the recommendations in the report other than those already set out within the body of the report.

13. HUMAN RIGHTS IMPACT

13.1 The Human Rights 1998 (HRA) requires public bodies to ensure everything they do is compatible with Convention Rights and makes it unlawful for a public authority to act incompatibly with those Rights. **Article 6 (A6)** of the European Convention on Human Rights (ECHR) is the right to a fair trial. The key elements of this include

- The right to a *fair* hearing;
- The right to a *public* hearing;
- The right to a hearing before an *independent and impartial tribunal*;

- The right to a hearing *within a reasonable time*.

13.2 When hearing an application, the proceedings of a non-judicial body such as the Licensing Committee, as opposed to an actual Court, need not meet the full requirements of A6 where there is a right of appeal from the Licensing Committee to a Court that does meet the full A6 standards and can consider all aspects of the case (even if that does not include a full re-hearing of the facts).

13.3 So, while it is good practice to make a hearing before the Licensing Committee as A6 compliant as possible, it will not be a breach of the HRA if it is not. Further, the hearing of all applications are subject to the principles of Natural Justice and the requirement for decisions to be 'Wednesbury reasonable'.

14. FREEDOM OF INFORMATION/DATA PROTECTION CONSIDERATIONS

14.1 Protocols agreed in relation to Licensing Hearings are within the Council's Constitution and will be accessible as part of the Council's Publication Scheme maintained under the Freedom of Information Act.

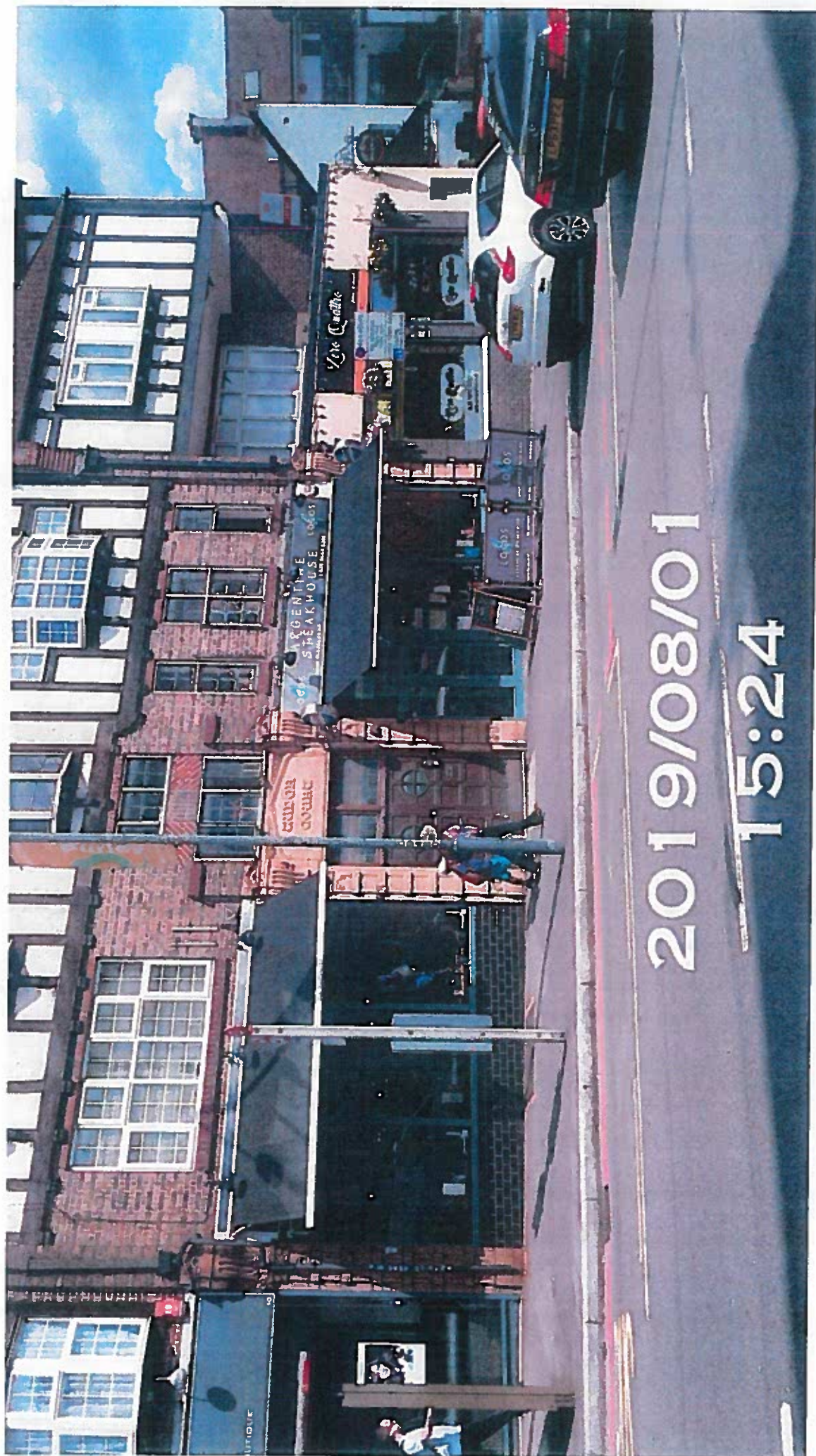

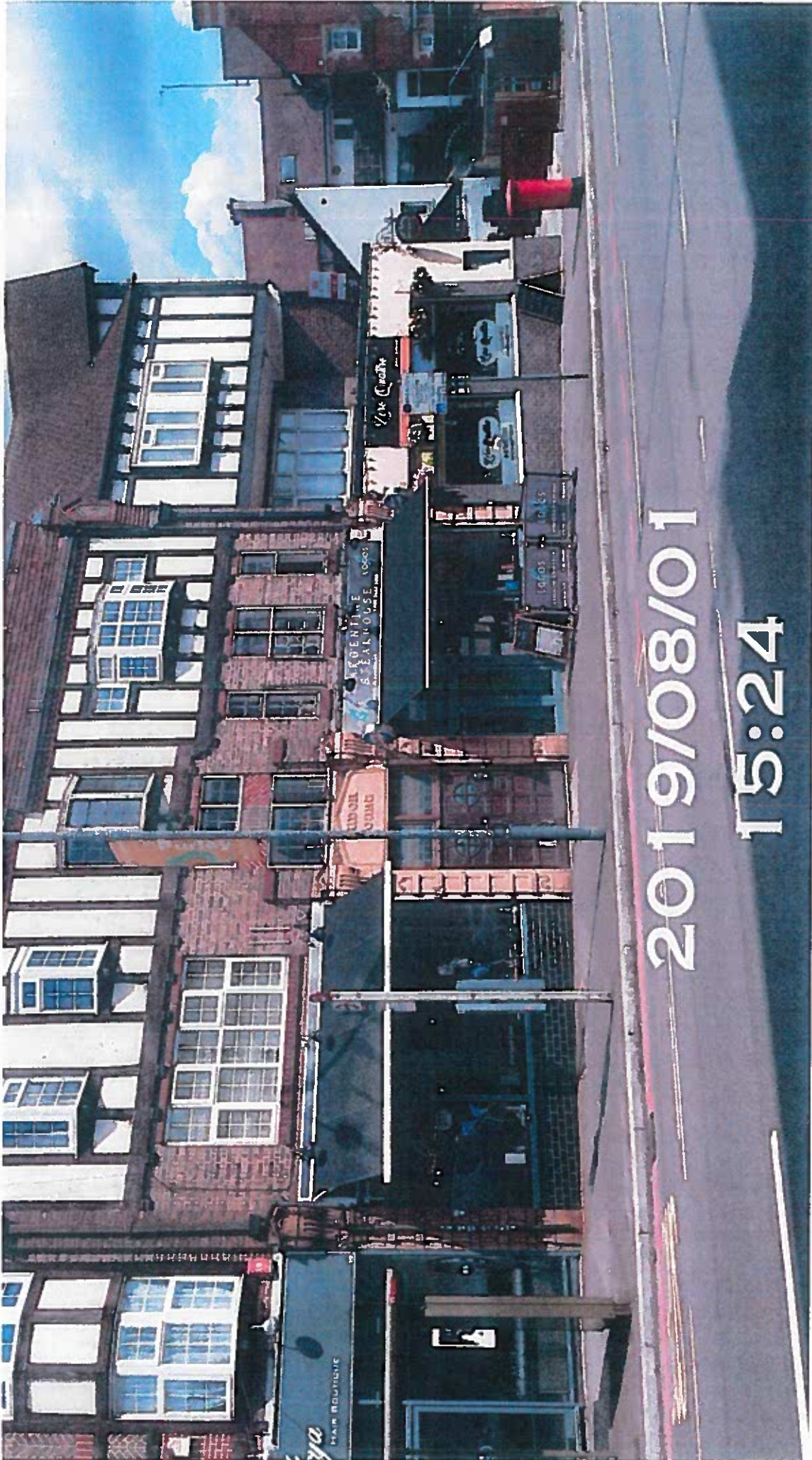

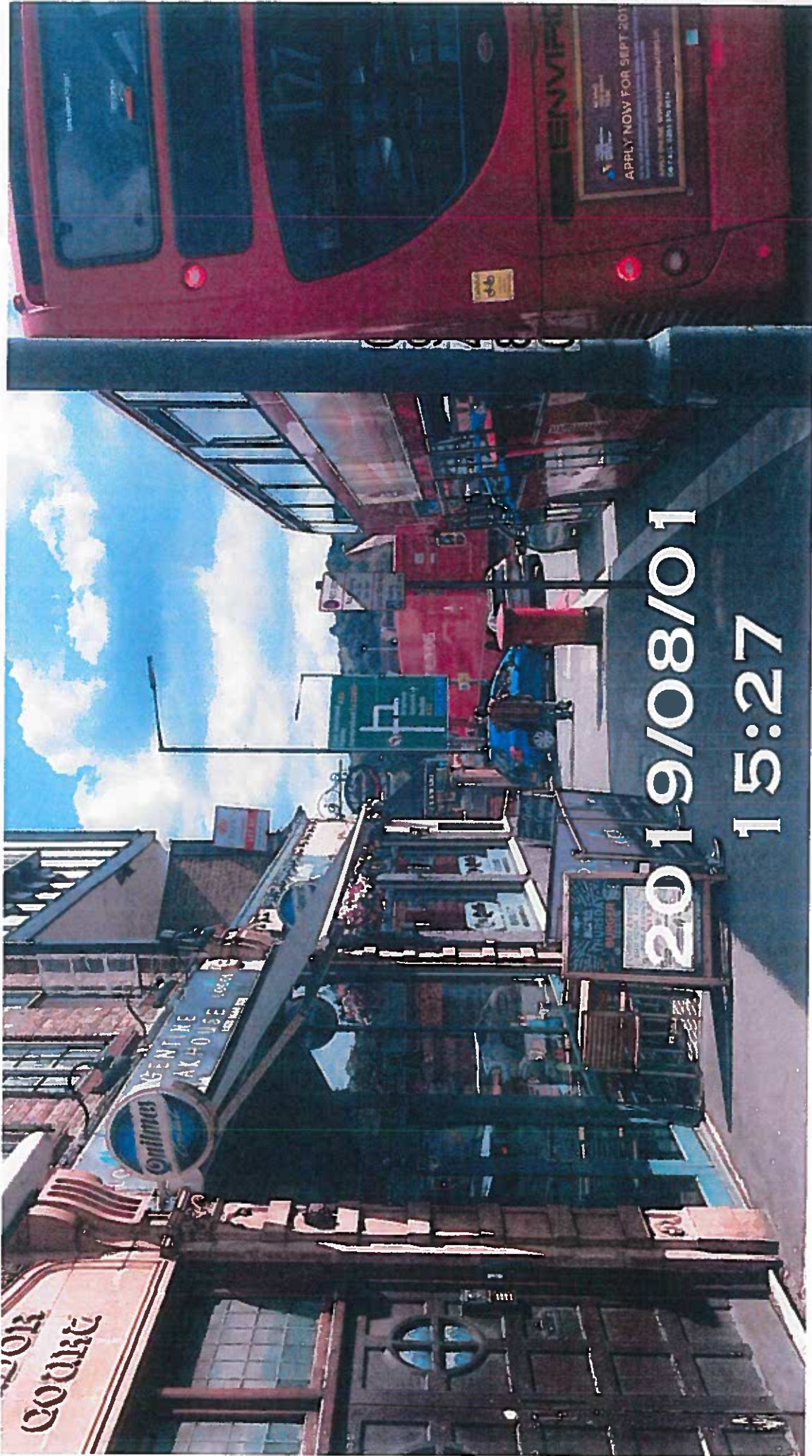
- 1.1 A copy of the application is attached at Appendix A3.
