The Chair advised that the application items would be heard in the following order: 20/01303/FUL 19 Downsview Road, Upper Norwood, London, SE19 3XD; 19/04564/FUL 1 More Close, Purley, CR8 2JN; 19/04478/FUL 4 More Close, Purley, CR8 2JN and 19/05032/FUL 6 More Close, Purley, CR8 2JN.

143/20 **20/01303/FUL 19 Downsview Road, Upper Norwood, London, SE19 3XD**

Demolition of existing dwelling and garage, erection of two storey building (with lower ground and roof space accommodation) comprising 9 flats with associated parking, amenity space and waste and cycle stores.

Ward: Crystal Palace and Upper Norwood

The officers presented details of the planning application and responded to questions for clarification.

Mr Ian Fleming spoke against the application.

Mr Neal Thompson, the applicant's agent, spoke in support of the application.

Councillor Stephen Mann addressed the Committee, in his capacity as Ward Councillor, and expressed his concern for the application.

The Committee deliberated on the application presentation heard before them having heard all the speakers who addressed the Committee, and in turn addressed their view on the matter.

At 6:48pm, Councillor Toni Letts arrived at the meeting.

Councillor Paul Scott proposed a condition for the parking spaces available are allocated to the larger sized family homes. Councillor Ben-Hassel proposed for a scope to provide a disabled parking space.

The substantive motion to **GRANT** the application based on the officer's recommendation was taken to the vote having been proposed by Councillor Paul Scott. This was seconded by Councillor Clive Fraser, with the inclusion of the proposed conditions.

The substantive motion was carried with five Members voting in favour and four Members voting against.

The Committee therefore **RESOLVED** to **GRANT** the application for the development of 19 Downsview Road, Upper Norwood, London, SE19 3XD.

144/20 **19/04564/FUL 1 More Close, Purley, CR8 2JN**

Demolition of existing two storey detached house and erection of a three storey building to provide 9 units, with associated vehicular accesses, car parking, child play space and soft and hard landscaping as well as cycle and refuse storage.

Ward: Purley and Woodcote

The officers presented details of the planning application and responded to questions for clarification.

Mr Joe Queening spoke against the application.

Councillor Oni Oviri addressed the Committee, in her capacity as Ward Councillor, and expressed her concern for the application.

The Committee deliberated on the application presentation heard before them having heard all the speakers who addressed the Committee, and in turn addressed their view on the matter.

The substantive motion to **GRANT** the application based on the officer's recommendation was taken to the vote having been proposed by Councillor Jamie Audsley. This was seconded by Councillor Toni Letts.

The substantive motion was carried with five Members voting in favour and four Members voting against and one Member abstained their vote.

The Committee therefore **RESOLVED** to **GRANT** the application for the development of 1 More Close, Purley, CR8 2JN.

At 8:02pm, the Committee adjourned the meeting for a short break.

145/20 **19/04478/FUL 4 More Close, Purley, CR8 2JN**

Construction of a part-three-/ part-four-storey building to accommodate nine flats (3 x 1-bed, 4x 2-bed, and 2 x 3-bed), a new vehicular access and four parking spaces, associated refuse and cycle stores along with hard and soft landscaping; following the demolition of existing dwelling house.

Ward: Purley and Woodcote

The officers presented details of the planning application.

At 8:10pm, Councillor Toni Letts returned to the meeting after the presentation had started and was therefore not entitled to vote.

Officers responded to questions for clarification.

Mr Siva Param spoke against the application.

Mr Duncan Gunn, the applicant's agent, provided a written statement in support of the application. This was read out by the Committee clerk.

Councillor Oni Oviri addressed the Committee, in her capacity as Ward Councillor, and expressed her concern for the application.

The Committee deliberated on the application presentation heard before them having heard all the speakers who addressed the Committee, and in turn addressed their view on the matter.

The substantive motion to **GRANT** the application based on the officer's recommendation as set out in the committee papers and the addendum was taken to the vote having been proposed by Councillor Leila Ben-Hassel. This was seconded by Councillor Paul Scott.

The substantive motion was carried with five Members voting in favour and four Members voting against.

The Committee therefore **RESOLVED** to **GRANT** the application for the development of 4 More Close, Purley, CR8 2JN.

146/20 **19/05032/FUL 6 More Close, Purley, CR8 2JN**

Demolition of existing dwelling house and the construction of two interlinked blocks to accommodate 9 flats with associated 7 car parking spaces, refuse store and cycle store facilities.

Ward: Purley and Woodcote

The officers presented details of the planning application and responded to questions for clarification.

Mr Mike Blackburn spoke against the application.

Councillor Oni Oviri addressed the Committee, in her capacity as Ward Councillor and expressed her concern for the application on behalf of the referring Ward Member Councillor Badsha Quadir.

The Committee deliberated on the application presentation heard before them having heard all the speakers who addressed the Committee, and in turn addressed their view on the matter.

The substantive motion to **GRANT** the application based on the officer's recommendation was taken to the vote having been proposed by Councillor Toni Letts. This was seconded by Councillor Leila Ben-Hassel.

The substantive motion fell with four Members voting in favour, five Members voting against and one Member abstaining their vote.

Councillor Paul Scott proposed a new motion to **DEFER** the application for further development. This was seconded by Councillor Leila Ben-Hassel.

Councillor Scott Roche proposed a new motion to **REFUSE** the application. This was seconded by Councillor Gareth Streeter.
