Please can you tell me whether a resident is legally obliged to have a council bin that they will not use on his/her premises?

I have a resident who does not need the capacity of the huge new paper recycling bin and has nowhere to store it. He wishes to give back to the Council his paper recycling bin but they are refusing to take it saying he must use it. He has undertaken to take his paper and card waste to a neighbourhood recycling centre so will not be using the new bin. He will not be putting paper or card in his landfill bin. Therefore why is he obliged to store council property on his property?

Please quote the relevant law on this matter so I can clarify the situation to my resident.

Reply

Section 46 of the Environmental Protection Act enables the local authority to require the occupier of a property to place the waste for collection in receptacles of a kind and number specified, which is exactly what we have done. It is doubtful that once we took the bins away that residents would actually go to the recycling centres with their waste, the likelihood is they would try and fit it all in the landfill bin, which is exactly what we don't want.

One of the key reasons for implementing the new scheme is to reduce our impact on the planet and if we allow people to give back the bins and go to the recycling centres instead, this would result in thousands of car extra journeys, producing massive levels of unnecessary carbon, not to mention queues at the sites.

I would like to ask why the recycling bins are so large? The fortnightly collections mean most households will barely half fill them. Why can't, as other councils have done, combine the plastic and paper bins? This would reduce the ridiculous number of wheelie bins and the number of collections.

Reply

Contamination is a major issue in the waste and recycling industry. By separating paper, we ensure the material is kept as clean as possible and as valuable as possible. Guaranteed income for recycled material is a key part of the SLWP contract which is delivering savings in excess of £5M p.a. This saving will be able to safeguard vital council services such as protecting our young and caring for our older citizens. For Croydon and would not have been possible had we mixed the recycling streams together.

Dear Croydon council I am fortunate enough to have sufficient space for all the bins but I am very concerned for those residents that don't have enough space. I think that this will lead to bins being left on the pavement causing obstruction to pedestrians and you cannot blame residents if they do not have enough space at the front of their property. How will you deal with this problem without penalising the residents?

Reply

No bins should be being left on the pavement, where we are aware of this happening we will work with the residents to ensure the bins can be stored within their property boundary and if they cannot be, will come up with an alternative arrangement.

As I am on assisted bin collection could you tell me why your dustmen come and collect the bin at the top of my drive but insist on leaving it at the bottom of the drive and sometimes on the pavement when they empty it. Obviously I am unable to bring the bin back up the drive due to limited mobility, so it has to stay there until someone visits me, which is not very often.

Reply

Our contractor is instructed to return assisted collections to the point of collection. If this isn't happening for you, please let me know your details and I'll ensure this is flagged up with the contractor and rectified.

I have yet to receive my new bins, I emailed the council on 31 August but as yet have received no reply. When am I likely to receive the new bins and why did I receive no collection on Wednesday 19 September. I had a caddy of food waste sitting in my garden for 2 weeks and I still have a box of cans, bottles etc.

Reply

Thank you for your question, unfortunately I do not know your individual circumstances but if you contact the Waste Services Team, officers will be pleased to assist and provide you with the new bins if your property is appropriate.

Why is the blue paper bin so enormous when paper is the least volume of rubbish I have? My 2nd biggest bin is general waste, I thought the idea was to encourage people to recycle?

Reply

The landfill bin should be the smallest bin in the set. The 240L blue bin was part of Veolia's bid position for the South London Waste Partnership contract, a contract which is saving Croydon residents over £5M per year, and reflects the fact that many people now receive deliveries from companies such as Amazon which are heavily packaged in cardboard.

I would like to know why all our houses and streets in this borough are now just a mass of ugly bins. Unless you have a side entrance, and can store bins in this area, which most people do not have, all these awful bins are at the front of our homes. It is ridiculous and any pleasant looking house or street in this leafy borough is now like a bin yard. And as for the collections, my food waste bin was missed on the first new collection day which I reported immediately.

11 useless emails later saying exactly the same thing plus, 20 mins on the phone to your call centre, I receive an email saying that the teams could not locate my bin which has been at the bottom of my drive (smelling foul because of the heat of the sun). Here are pictures of where the bin has been located all week. Does it look difficult to find? No-one has come near the house to look for it!!

It is a complete lie from the council saying that the bin cannot be located. This is a dreadful situation and has been managed appallingly.

Reply

I hope you would agree that I can't be expected to know the individual circumstances of each missed collection, however I will say that reported missed collections in general are under 1% of the total number which says to me that the number is manageable. If you provide me with your details I will ensure officers look into this and provide a response.

In accordance with Agenda Item 6[a] I would like to receive an answer to the following question, please:

Whilst noting the Clean Green Croydon report of Councillor Collins, would you please state:

[a] The cost of implementing the scheme to date and the final estimated cost

[b] whether the council is on target to achieve an increase of recycled refuse from 38% to 50%, by what date will this be achieved and will the 10 year target be met

[c] in which full year will the SLWP £5 million cost reduction be achieved and for how many years will this apply

Reply

- a) We anticipate the cost of rolling out the scheme to be in the region of £3M.
- b) We are currently a month into the new service so it is too soon to be drawing conclusions about the impact of the scheme, especially as until recently we have been continuing to take side waste in order to ensure a smooth transition into the new service.
- c) I would expect to see the 50% target reached in the next full financial year – so 2019/20.
- d) The £5M saving is an annual saving so will apply for the length of the SLWP contract which is 8 years with two optional extensions of 8 years, so up to 24 years, which would be a saving of over £120M to Croydon taxpayers.

I have asked my local ward MPS in regard obstruction of the pavement, they replied that Pavement Obstruction is the Councils duty to uphold free obstruction free access on pavements in the borough, through their by-laws strict direction on obstruction is qualified. It is MPS duty to uphold the law on obstruction of highways of the borough (section 148 Of the highways act 1980) as reported in Octobers 2018 Safer Neighbourhoods newsletter.

Pavement Obstruction question:

Considering that pavements in the borough need full obstruction free access for All, Can the cabinet member for a clean & green Croydon fully explain in detail the Councils own By-Laws which direct him to oversee, plus allow the Pavements of our borough to be Littered with the obstruction of Bins, restricting the free movement access of prams, foot traffic, Wheelchairs ALL, WHO is liable to be charged with obstruction?

Reply

The Council's position is that no bins should be left on the pavement. We are aware of some roads which were not suitable for the new service where our contractor wrongly delivered bins and have worked to rectify these as quickly as possible and will continue to do so where we see bins on pavements. The delivery process has also flagged up a number of streets where landfill bins were already being placed out on the pavements, and we are working with our contractor, Veolia to provide long term solutions to enable us to permanently remove these bins and clear the Streetscene of obstructions.

Could the council please explain the safe process for collecting recycling and refuse. Since the unfortunate fatal accident on the corner of Cherry Tree Green and Oakapple Close the operators are still reversing around the corners of roads without due care and attention. In some cases they are going up onto the corner of the pavement and kerb in order to navigate the road. I believe that this is extremely dangerous both for members of the public and the operators. Please could you ensure that all the vehicles and staff operate safe practice when collecting our refuse without mounting the pavement and kerb. This is dangerous for elderly, vulnerable disabled residents. I am particularly concerned for those with hearing and sight impediments. We certainly don't want any more fatalities.

Reply

Firstly I was saddened to hear about this tragic incident and my thoughts are with the family at this time. As part of the SLWP contract, Veolia have produced detailed method statements detailing their approaches to health and safety. This includes the production of Route Risk Assessments (RRAs) to enable them to assess collection rounds and ensure minimal impact to the public whilst also reducing the risk to staff. All crews will have copies of all route risk assessments on the vehicle to enable quick access. Veolia will carry out these detailed RRAs for all of the routes within the Boroughs to ensure that the round takes into account any highway issues or instances where the collection could be an inconvenience to the public. An example of Route Risk Assessment is attached at Appendix 1.1e.

The RRA aim to identify any significant risks such as:

- Known accident black spots
- Collections at or in the vicinity of schools
- Collections at or in the vicinity of Medical, Nursing and community centre collections
- Stopping/Loading on sharp/blind bends
- Double side / offside collection on busy main roads and/or on a dual

carriage way

- Residential roads/routes which are used as short cuts by other road users i.e. “Rat Runs”
- Slow collections which cause known significant traffic build up
- Reversing manoeuvres where a reversing assistant cannot be utilised due to added danger.

Veolia will plan the routes to reduce the requirement for reversing and avoiding reversing is not practical then Safe Systems of Work will be implemented to reduce the associated risks.

Where the crew is a driver plus one, a trained reversing assistant will be used, unless identified as too dangerous by the RRA in which case a site specific Risk Assessment will be undertaken for the location.

Regarding Recycling Shredded Paper. Residents regularly produce quantities of shredded paper for recycling. Shredded paper is a clean asset worthy of proper recycling. We need to shred paper for obvious and well-publicised security reasons. It should not be consigned to landfill. Previously, shredded paper was placed with other paper and card in the recycling box. On the matter of shredded paper the new recycling regime is confused and unfit for purpose:

FIRSTLY we are advised NOT TO PUT shredded paper in the new, large wheeled bins. This is apparently to 'protect the machinery from clogging'!

Question: Shredded paper is not new so why is the 'machinery' - by now - still not capable of a basic requirement in order to be fit for purpose?
SECONDLY we are advised to PUT OUR SHREDDING INTO ENVELOPES, PAPER BAGS, OR CARDBOARD BOXES...

Question: How is this a serious, practical, suggestion for handling anything other than a trivial amount of shredded paper?

Question: Also assuming the unlikely - that large paper bags are to hand - how would the collection crews then handle the contained shredding?

Question: Would the large paper bags or cardboard boxes be put into the vehicle paper compactor - to be burst open? Or would they be thrown into the landfill compactor?

The new, over-large bins have ample capacity for shredded paper. We need it recycled properly and without this ridiculous song and dance.

Reply

Initially the boroughs were told that shredded paper could not be accepted in the new recycling scheme, however, I'm pleased to say that following discussions with our contractor, they have agreed that shredded paper can now be accepted – all we ask is that residents place it inside either an envelope or a paper bag before putting it inside the bin in order to stop it blowing down the street on collection day.

Q 1: Are we legally obliged to use the new bins deposited outside our homes by Croydon Council?

Q 2: Will all 'KPIs' (key performance indicators) for the new waste management scheme be made available for public scrutiny? If so - how often (monthly/quarterly or yearly) Including revenue generated by selling energy to the National Grid?

Q 3: Who will be responsible for monitoring the fumes emitted from the incinerator's chimney - what safeguards will be in place for public safety/health? Will reports be made available for public scrutiny?

Q 4: What guarantees/controls are in place to ensure NO material that could be recycled is incinerated (because it is cheaper to burn, rather than go through the process of recycling or we currently do not have facilities to recycle certain types of material)?

Q 5: Landfill costs are increasing... is the appointed contractors intention to simply burn our waste (and perhaps some of our recyclable material too?) because it is cheaper to do so and it provides an energy source that can be captured and provide revenue?

Q 6: Much has been said that countries that used to take our 'recycling material' do not want it anymore... as a country we have not invested enough in regard to recycling industries... Did the Council explore other options to dealing with our waste (including recyclable material) rather than just burning it?"

Reply

Q 1: Section 46 of the Environmental Protection Act states that the local authority can require the occupier to place their waste for collection in receptacles of a kind and number specified which is what we have done via the introduction of these bins.

Q 2: The Council will produce a monthly dashboard showing performance against the key performance indicators in the contractor. The SLWP will

also be publishing information about the energy generated from the ERF on an annual basis.

Q 3: The Environment Agency are the regulatory authority responsible for monitoring the site. The facility complies with all applicable environmental standards and any reports pertaining to the environmental standards of the site will be made available as per the site licence requirements.

Q 4: It is not cheaper to burn waste than to recycle it, it is considerably more expensive. It costs in excess of £100 per tonne to burn waste, whereas the council receives guaranteed income from the sale of recycling. Therefore, there is no advantage financially or otherwise to burn waste rather than recycle it.

Q 5: It is considerably more expensive to burn waste than it is to recycle it. The cost per tonne to burn waste is in excess of £100/tonne as opposed to recycling which generates in excess of £100,000 of guaranteed income for the borough as part of the contract.

Q 6: As opposed to 'just burning' the waste, the energy from waste facility at Beddington Lane, will do exactly that – create energy. This state of the art facility The ERF has been designed to process around 275,000 tonnes of non-hazardous residual waste a year. Wider environmental benefits will include the landfill diversion of up to 95 per cent of waste delivered to the facility and the generation of up to 26MW of electricity, which will power the facility itself and supply over 22MW to the National Grid. To be clear, the ERF facility should only be used for non-recycling waste, which is why we have invested in the new waste collection system, to ensure we capture as much recycling as possible.

I am the manager of a block of 38 retirement apartments, and for over 6 months have had problems with general bin collections then in trying to persuade the council occasionally to collect them on the agreed day, and then trying to persuade your contractors to unlock a door to get to the bins, then empty the bins, and then lock it again after collection.

It took 3 months getting new bins to replace the broken ones and I finally thought it was sorted as for a couple of weeks all was well, then last week missed collection and the week before the bin rooms doors were left unlocked and wide open.

The council are very hard to get hold of a person, and voice message says got to web site, which lies as says bins collected!

When if ever will you finally sort out your contractor's incompetence?

Reply

Thank you for your question, unfortunately I don't know the individual circumstances of your block, but if you pass the details onto me I will ensure you receive a full response from officers. Usually the responsibility for ensuring bin stores are locked and unlocked before and after the collection is the responsibility of the caretaker of the site, rather than our contractor, which is perhaps the reason for some of the difficulties you've experienced, but again, without knowing the individual circumstances, it's hard to answer your question in this meeting.

Why has the council introduced a new bin policy that has not delivered any new bins to many residents across the borough?

Why have the environmental service department of Croydon Council asked residents to order new bins online which were supposed to be issued out by September the latest?

How does the council expect residents with small properties to store these new bins?

Reply

The council has delivered around 250,000 bins as part of this rollout. If people have been missed, they can contact the waste services hotline and we will arrange for the bins to be delivered as soon as possible. In the meantime, we will continue to collect waste from anyone presenting waste in the previous containers.

We set criteria for the suitability of properties for the new service and that was that the bins had to be able to be accommodated on the property and be manoeuvrable. Should anyone believe they have wrongly been delivered bins based on this criteria, they should contact the waste services team who will conduct an assessment.

What is the Council doing to control the service performed by those collecting the contents of the various bins? And how does the Council ensure it is kept correctly apprised of the true state of this service? I am concerned that the Council does not appear to have sufficient control over the service AND that a change in the complaints system is both unhelpful and hides what is going on:

- 1) The recent roll out of the new bins has been very disorganised. Many people did not receive the new bins on time and some are still waiting, including a friend of mine who is still waiting for the new landfill bin. I spent some time chasing before I got my new bins (late). Oddly, today, I found two more wheelies loitering outside my gate. As all my bins are in plain sight, this was careless.
- 2) I have had a lot of problems with my collection over the years. At one point, and for about six months, I had to report missed collections almost every week. Eventually, a manager from the Council came, saw the problem and told me he would give instructions for the binmen to collect from just inside my property. This worked for some time. However, more recently, the problem reoccurred. Speaking with a binman, he said he had no knowledge and said he couldn't go inside the property in case he fell over(!) I have never considered my property lethal and wondered how the binmen were communicate with and whether their insurance covered the for all accidents on the job-on my property and the public property.
- 3) The online complaints system allows the initial reporting of missed collections. If a collection is reported missing within a certain time frame, a further or replacement collection is supposed to take place. However, having had the further or replacement collection fail, I found that they system did not allow me to report the further failure. Hence my concern over the unhelpfulness and potential false view of the service."

Reply

- 1) I'm pleased to say that the delivery of the bins went really well and

that the vast majority of people in Croydon received their bins without any problem and are using them well to recycle, so much so that the recycling rate for September has increased to 45%. Clearly in a rollout of a quarter of a million bins, there are going to be some errors and our staff and contractors have been working tirelessly to ensure these are rectified as quickly as possible.

- 2) I don't know the individual circumstances of your property but if you let me know, I will arrange a full response from officers.
- 3) I am not aware of your individual case, but under the new contract, missed collections must be reported within 2 working days in order for us to return. The best way to report a missed collection is via MyAccount which creates an automatic instruction for our contractor to return and rectify.

1. The Council's slogan is ""Take Pride in Croydon"". How can we take pride in a town in which our once beautiful front gardens, and even at times our pavements, have become a sea of big, ugly, grey, plastic bins?
2. The new 240 litre bins issued to Croydon residents are so large that for almost all households they will still be mostly empty at the time of the fortnightly collection. Does the Council intend to reduce the frequency of collections to monthly or less, as has already happened in Conwy and elsewhere?
3. The new bins are heavy and unwieldy. How are the less strong members of the community expected to move them?
4. What alternatives are available to those who prefer not to keep the new collection bins

Reply

1. I think that setting an ambitious environmental agenda which is set to see us become one of the highest recyclers in London is something that all residents can be proud of. What we have set out to achieve is not an easy thing to do, we were always aware that there would be a period of disruption, but both officers and our contractor have worked extremely hard to ensure that this has been kept to a minimum.
2. Many Croydon residents are currently finding a way to fill in excess of 240L of landfill despite over 70% of this waste being recyclable. That is the reason for the smaller landfill bins and the larger

recycling bins. There is no compulsion for anyone to present waste at every single collection, although we will collect it if they do. There are no plans to reduce the frequency of collection.

3. The new bins should be easier to manoeuvre than picking up and lifting the boxes, however, for those who aren't able to manoeuvre the bins and have no one who can help them, they can apply for an assisted collection where we will collect the front of the property and return it to the same place.
4. None, it is not a matter of preference, all properties that are suitable for the new bins are expected to use them.

Councillor Stuart King, Cabinet Member for Environment, Transport & Regeneration – Job Share (Acting)

It has been reported that driverless cars are being tested on Croydon. Has the Council had any involvement in this, has it sanctioned the testing or has the Council help fund the testing? If yes, what is the benefit to Croydon residents and Croydon taxpayers of the Council's involvement?

Reply

Autonomous vehicles will soon be a reality in London. [FiveAI](#), a leading UK company developing technology for driverless vehicles, started data gathering in the Boroughs of Croydon and Bromley last month and will begin driverless testing early next year. This is in preparation for the testing of their shared driverless passenger service in London which is expected to be trialled towards the end of 2019. The vehicles will always have safety drivers in control from the driving seat.

Croydon Council is not funding any element of the project. It receives the cost of staff time spent on it from Central Government via Innovate UK.

We are keen to ensure that London maximises the potential benefits arising from this technology and minimises the potential down sides. We are also keen to understand the potential the technology offers for new types of public transport services, particularly in the south of Croydon.

Being involved in trials like Streetwise will help deliver the Mayor's Transport Strategy commitment to develop the appropriate mix of policy and regulation to ensure connected and autonomous vehicles are used in a way that is consistent with the Healthy Streets approach and wider Mayoral objectives.

Please provide the most easily available information on the number of pupils in each year group in each school in Croydon alongside the number of planned places in each of those year groups in those schools.

Reply

The tables below outline the number of pupils on roll in each year group across Croydon's schools alongside the Published Admission Number (PAN) for each corresponding year group. The data has been divided into educational planning areas; six for primary and two for secondary. The PAN is set at the entry point of each phase of education; Reception for primary and infants, Year 3 for juniors and Year 7 for secondary schools. Outside of these entry points, schools may vary their admission number and therefore some schools may be operating at a different admission number than stated below.

The Number on Roll (NOR) has been populated using the latest available data - Summer (May) 2018 School Census Data - and therefore the year groups coincide with the 2017/18 academic year.

In order to maintain sufficiency of school place across the education estate, it is important to retain a degree of flexibility in the system to respond to parental choice, demographic change and unexpected increase in demand for school places. Croydon aim to have a 5% surplus places across primary and secondary schools.
