A114/19 **19/03438/FUL 15A Normanton Road, South Croydon, CR2 7AE**

Erection of 3 houses with associated parking and landscaping.

Ward: South Croydon

The officers presented details of the planning application and officers responded to questions for clarification.

Referring Ward Member Councillor Maria Gatland spoke against the application.

Councillor Letts proposed a motion to **APPROVE** the application based on the officer's recommendation. Councillor Scott seconded the motion. There was a request for a condition for protection of the wildlife and mitigation measures for planting and trees during and after the construction.

Councillor Perry proposed a motion to **REFUSE** the application on the grounds of over development in the design, out of keeping within the local area and a detrimental impact on the adjoining neighbours and loss of natural environment. Councillor Streeter seconded the motion.

The motion to approve was put forward to the vote and carried with three Members voting in favour and two Members voting against. The second motion to refuse therefore fell.

The Committee therefore **RESOLVED** to **GRANT** the application for the development of 15A Normanton Road, South Croydon, CR2 7AE.

A115/19 **19/03689/FUL Crakell End, Hartley Down, Purley, CR8 4EA**

Demolition of existing detached bungalow and garage; erection of two pairs of semidetached dwellings (4 dwellings in total) with car parking, refuse and recycling store, soft landscaping and new vehicular access.

Ward: Kenley

The officers presented details of the planning application and officers responded to questions for clarification.

Councillor Badsha Quadir and Mr Alex Strong spoke against the application

Mr Simon Grainer, on behalf of the Applicant, spoke in support of the application.

Councillor Letts proposed a motion to **APPROVE** the application based on the officer's recommendation. Councillor Khan seconded the motion.
