2.1 This report updates Members on a change to its appointments to Outside Bodies made at the Annual Meeting in May 2022.

3.1 Functions of the full Council.

The following appointment was made by full Council pursuant to its powers set out in Part 2 Article 4 paragraph 4.1(g) of the Constitution:

(i) That Councillor Mike Bonello be appointed as a Council Trustee to the Church Tenements Charity.

3.2 After the initial appointment was made in May 2022 the Church Tenements Charity informed the Council that its membership requirements had changed and that as a result the Council had appointed one Trustee too many.
