In CQ054-17 in relation to the Council Sunshine Tax, the Cabinet Member states that 13 businesses have so far surrendered their street trading licences citing the increase in fees as the reason for withdrawing.

Could the Cabinet Member please list these businesses and in doing explain whether she believes their withdrawal indicates a failure of the policy?

The answer also stated that 8 businesses have had enforcement action taken against them as a result of non-compliance. Is the Cabinet Member able to reveal who these businesses are, what the enforcement action was issued for and what the procedure was for enforcement? E.g. were fines issued and if so how much?

Reply

I can confirm that 13 businesses have surrendered their street trading licence and when doing so, indicated it was because of the new fee structure. Some 169 businesses in the borough have maintained their street trading licence. The purpose of the fee review was so that the council was legitimately recouping its expenditure in providing the licensing service. So, in that respect the fee review has been a success. The vast majority of business have decided to continue with paying for street trading licenses. The fact that a small number have decided to cease trading on the street is ultimately a commercial decision for them but the council could not continue subsidising commercial activities, as it had effectively been doing previously. With respect, I do not think it is appropriate to publicly list premises who have made the decision to surrender their licence, as the question asks, as the information was provided to the council in confidence.

I can confirm that eight businesses have had enforcement action taken against them. All were issued with a fixed penalty notice (FPN) for overspreading, which means they were not staying within the area permitted by their licence. An FPN costs £100, reduced to £60 if the recipient pays within 14 days. Where the recipient of an FPN is a sole trader, we would not be permitted to disclose their details due to data protection requirements. Where the recipient is not a sole trader, there is a risk that disclosing their details may prejudice the commercial interests of the particular businesses.
