The project manager can be a third party beyond the London Borough of Croydon, such as a Registered Provider or Croydon Healthcare NHS Trust.

The Spatial Planning Service ensure the project that is the subject of the IFG bid aligns with the Council's Infrastructure Delivery Plan (IDP), Growth Zone Project Programme or Capital Strategy.

When an IFG bid is seeking Section 106 funds, the Spatial Planning Service check compliance with the parent Section 106 Agreement.
