- 4.3 In accordance with the above Constitutional requirement, the Majority Group has been consulted and Council is asked to appoint Councillor Maggie Mansell to the role of Chair of the Health and Wellbeing Board with effect from 1 February 2018 for the remainder of the 2017/18 municipal year.
