2. 3. Contracts: in which the Member or their partner or a body in which either have a beneficial interest with the London Borough of Croydon, for the provision of services, goods or works which are not already fully discharged.

4. Land: in which the Member or their partner has a beneficial interest, within the area of the London Borough of Croydon.

5. Licences: in which Member or their partner has a beneficial interest, with the London Borough of Croydon.

6. Corporate Tenancies: in which the Member or their partner has a beneficial interest, with the London Borough of Croydon, where the landlord is the London Borough of Croydon and/or the tenant is a body in which the Member or their partner or spouse has a beneficial interest.

Securities: in which the Member or their partner has a beneficial interest, with the London Borough of Croydon; a body, to the Members knowledge, has a place of business or land in the London Borough of Croydon and/or the total nominal value of the securities exceeds £25,000, or one hundredth of the total issued share capital of that body' or if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which Member or their partner or spouse has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
