1. Introduction

1.1 Purpose of Equality Analysis

The council has an important role in creating a fair society through the services we provide, the people we employ and the money we spend. Equality is integral to everything the council does. We are committed to making Croydon a stronger, fairer borough where no community or individual is held back.

Undertaking an Equality Analysis helps to determine whether a proposed change will have a positive, negative, or no impact on groups that share a protected characteristic. Conclusions drawn from Equality Analyses helps us to better understand the needs of all our communities, enable us to target services and budgets more effectively and also helps us to comply with the Equality Act 2010.

2.1 Purpose of proposed change (see 1.1 above for examples of proposed changes)

The Department of Work and Pensions (DWP) has announced the Household Support Fund (HSF) to support vulnerable residents between 1st April 2022 to 30th September 2022.

Overview and aim of the fund

Croydon has been allocated £3,013,689.49.

The primary aim of the fund is to reduce food & fuel poverty between April and September, by providing residents with access to food and fuel who may otherwise go without. Support will also be provided for other essentials associated with food & fuel. This includes but isn't limited to, fridge, freezers, cookers, microwave and boiler repairs. Where needed the fund will be used to support with wider essentials that can help reduce poverty over the next 6 months including help with other bills, clothing & one-off housing cost (where no other support is available).

The fund also empathises the need to support children in vulnerable households, therefore at least 33% of the Household Support Fund must be used to support families with children. A further 33% of the fund must be ringfenced to support Pensioners. Up to 33% can be used to support other vulnerable households with an emphasis on supporting residents who are unable to increase their income through work (carers, long term disabilities)

Below are details on how Croydon aims to achieve the above.

Targeted work

Croydon will target vulnerable residents that will be in eligible for Household support fund. This will be achieved by using internal & external services.

Internally

A total of £1,207,935.66 has been allocated to support pensioners and vulnerable residents, in particular those with medical conditions that require heating to manage their condition. A collaborative piece of work is being done across Adult Social Care, Housing Benefits & Council Tax support and the Discretionary Support team to identify these residents. The fund will help bolster the support they already provide to ensure that fuel & food poverty can be reduced. Services have already begun to identify residents and will continue to do so between now and September.

Externally

The fund will not be allocated to community groups and other third-party organisations. However, we will be working with them to promote the scheme, especially among hard-to-reach groups such as pensioners.

Schools

To tackle food poverty among children during the school holidays £1,004,536.16 has been allocated to Croydon schools. Schools will provide food during 4 weeks of school holidays for 17,500 families in receipt of free school meals. An additional £216,000 will be provided to schools to provide discretionary awards for families not in receipt of Free School Meals.

£25,000 will be provided to chosen schools to set up the Felix Project food stops within schools. This will provide long term food stability within the borough for families with children of school age.

Applications process

To ensure that Croydon can reach as many residents as possible with the Household Support Fund £440,185.83 has been made available for direct applications and referrals from other external and internal services. The Discretionary Support team will administrate this using their knowledge and past experience to maximise the fund and support the right applicants.
